PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The ME DEP Air Laboratory provides ambient air analysis for volatile organic compounds (VOCs) using a gas chromatograph/mass spectrometer (GCMS) and Entech Preconcentrator with autosampler by EPA Method TO-15 in support of the Monitoring Sections Hazardous Air Pollutant (HAPs) network. Air samples are collected into stainless steel canisters. The canisters can be cleaned and reused many times over their lifespan. The laboratory periodically purchases new canisters to replace older canisters that have been removed from sampling rotation. Canisters are most commonly removed from rotation due to leaks but also, over time the coating inside of the canisters can degrade causing chemical instability and preventing the lab from meeting quality control requirements. High quality canisters used for sample collection and calibration standard preparation are required to accurately see low concentration VOC's.

Additional replacement consumables for the laboratories two Entech autosamplers are also needed. The parts are unique to Entech Instruments autosamplers. Since we will be using the same funding source, those items are also included in this quote to simplify the purchase to one transaction.

Silonite air sampling canisters have been purchased from Entech Instruments previously and have been found to be of top quality due to their unique inert ceramic coating technology. The canister valve is engineered by Entech to provide a double seal which ensures longer leak-free operation. The consumable parts are needed for Entech autosamplers used in the laboratory. We have found that consistency between equipment and supplies is essential to maintain quality assurance standards.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The Air Lab has purchased many supplies and instrumentation through Entech Instruments and have always found prices to be fair and reasonable. Another laboratory vendor, Restek, sells similar canisters for \$950 each. Entech has also offered a 32% discount off the list price of Silonite canisters. This allows us to save \$2,365.44 on the canister purchase.

4. Describe the plan for future competition for the goods or services.

By purchasing the new canisters and consumable parts, we will be able to continue analyzing ambient air samples by EPA Method TO-15 for the monitoring network as well as special studies. We will continue to update our inventory to replace canisters that can no longer hold sufficient vacuum to support our ambient air monitoring sample collection and analysis as well as canisters that will no longer meet our high-quality assurance standards due to age allowing future competition at that time.
