The Marshals have recently acquired necessary upgrades to their firearms for a greater focus on public safety. The access to Semi-Automatic 5.56 magpul rifles requires the utilization of a federal .223 round that is not currently available via the master agreement held by the State for security force ammunitions.
2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.	AAA Police Supply was chosen because they currently hold the Master Agreement with the State for security forces ammunitions. Upon contacting them it was realized that the necessary ammunitions were not available via the master agreement, but were available via AAA Police Supply. The speed in which these ammunitions were required necessitated utilizing a supplier who already held a vendor code and familiarity with servicing goods to the Judicial Branch Marshals.
3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.	Rates are inline with expected prices and are within the equivalent range of goods provided through the Master Agreement won by AAA Police Supply.
4. Describe the plan for future competition for the goods or services.	Neither these goods nor their equivalent are covered under the existing Master Agreement with AAA Police Supply. The MJB will work with DAFS to make sure these are included in future renewals or RFPs for these goods.
