PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The availability of recovery housing resources supports Governor Mills' executive order #2 FY19/20 dated February 6, 2019, section IV-B. This contract for services also supports the objectives of the Opioid Response Strategic Action Plan – "Priority I in the Plan (Strategy 20): Build and support recovery-ready communities includes as a current activity, *c. funding for recovery housing units* and as a priority future activity: *g. Increase Funding for safe and affordable housing for individuals in recovery.*" This service provides subsidized beds at qualifying Recovery Residences to support individuals with varying abilities to pay. It is crucial to support low-barrier access to these services.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

This service had been initially administered by Maine Housing but transitioned to this provider in 2023. It is OBH's desire to continue to offer financial support to certified Recovery Residence's, as they are an important part of the Recovery service continuum of care.

MARR was selected as the only qualified vendor to provide these services. MARR, is an affiliate of the National Association for Recovery Residences (NARR), is the State designee for the ethical and sustainable management of high-quality recovery residences throughout the State of Maine. MARR oversees the certification of Recovery Residences utilizing the national standards established by NARR which include review of house operations, policies, and physical inspection.

MARR provides training and technical assistance to current and prospective Recovery Residence operators related to best practices, ethical standards, and safety. In September 2022, MARR launched a data collection initiative utilizing the REC-CAP resident data management platform. In addition to managing intake, move-in/move-out, and other client management functions, houses will now collect recovery capital scores for all residents at move-in and at 45-day intervals to help demonstrate the behavioral changes residents experience in response to the safe, structured, sober housing offered at Recovery Residences.

As the certification entity for Maine Recovery Residences, MARR possesses unique industry information, and information unique to the house operators, that allows them to create, implement, and manage the bed subsidy program outlined in this agreement. MARR's industry knowledge was critical in the creation of the bed-night-rate which established the foundation of this subsidy. In establishing the rate, MARR consulted with other State affiliate who administer similar subsidy programs in partnership with their States Recovery Departments.

Further, because MARR is currently leading the enhanced data collection initiative for Recovery Residences, MARR is able to provide detailed analysis about the positive impact of a bed subsidy for new residents in eligible houses.

MARR supported the development of the model redesign, researching best practices used in other States and administered by other NARR affiliates. This new model has allowed a significant expansion of the Residences supported by these funds, increasing the number of houses participating from 17 to 54.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The level of subsidy, or bed-night-rate, was determined by comparing the average operating costs and tenant payments for Level 2 and Level 3 Recovery Residences. The bed-night-rates and allocation of subsidized beds was assigned based on the total number of beds at each residence as follows:

Total beds	Subsidized beds
1-7	1
8-13	2
14 or more	3

Level 2 MARR Certified houses may receive \$23/bed night

Level 3 MARR Certified Houses may receive \$25/bed night

Additionally, allowances for a single additional subsidized bed were included for Recovery Residences in rural counties where access to MARR Certified Recovery Residences is very limited.

Based on these financial calculations, this newly designed program has expanded access of Recovery Housing subsidy funds from 17 MARR certified houses to 54 who meet the eligibility requirements.

Costs for the administration of this service were negotiated with the provider and are in line with similar services provided in Maine.

The Department does not plan to competitively procure this service in the future.


