### PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

T01-275 is a 2014-Wheeler plow truck with 3210 hrs. that was having fuel leak issues. Allegiance's technician ran diagnostics and determined that the source of the fuel leak was a crack in the high-pressure pump nozzle. To correct this issue, the technician had to replace the pump. totaling \$5069.68 were made. The decision to move forward with these repairs was made consistent with Maine DOT Fleet Management's guidance considering the vehicle's age, miles, and anticipated replacement schedule. This truck is not scheduled for replacement. The replacement cost of the truck is about \$180,000.00. The decision to use a commercial repair facility was made after careful consideration of the availability and expertise of Department personnel and the operational need to get the equipment back in service.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

The Fleet garage could not make these repairs in a timely manner due to being low on technicians. With the work unable to be done in house, we reached out to Allegiance Truck to determine whether or not they could accommodate the job. After talking to them, Allegiance Truck in Bangor could get it right in for the repairs needed.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Allegiance is an International dealer and Fleet Services has negotiated a lower labor rate with them, we have also had work done there in the past and when compared with the other International dealers, their rates were the same or in some cases a little cheaper. They were able to efficiently and cost effectively carry out a repair of this significance. This repair would not have been something the department could complete in a timely or cost-effective manner.

4. Describe the plan for future competition for the goods or services.

If we could convince more International truck dealers and service facilities to move into more locations in the state it would potentially foster better competition. We will keep looking to carry out work in house. If unable, we will move forward with vendors that will get the trucks back on the road the quickest.






## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Department of Transportation (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you.
