The Downeast Salmon Federation (DSF) will provide oversight for anadromous fish passage improvements at former powersite below Meddybemps Lake on the Denny's River, fish passage designs for the Chain Lakes project in the Machias, and fishway maintenance at multiple projects including baffle replacement and repair. The improvements will consist of contracting and overseeing a qualified construction firm for the removal of a dam and regrading of a channel, overseeing an engineering consultant, providing permitting support, and purchasing and installing baffles.

The Downeast Salmon Federation has been working with the landowners at the site and completed the fish phase of these projects, and has received partial funding from DMR last year and the USFWS for implementing this project. The Downeast Salmon Federation has extensive project management experience with this project and enough time and capacity to complete this project. DMR does not have program staff that can oversee the construction and permitting, particularly given some budget reductions with contract staff at DMR and the remote nature of this project. The Downeast Salmon Federation is also contributing funding to this project. Without the Downeast Salmon Federation managing the project, DMR could not complete this project.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

DMR is provided only partial funding for this effort and the Downeast Salmon Federation has secured additional funds to make the project complete. The Downeast Salmon Federation has an agreement with a subcontractor who can complete this work at low cost, can complete the project within the agreed upon timeframe, and has a proven track record of project completion. DMR has worked with the Downeast Salmon Federation on a number of projects where they managed the construction.


If in the future, if another vendor becomes available that has the adequate facilities and capabilities to fill this role, we will evaluate each equally.
