### PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The devices purchased herein will be deployed on recreationally- and commercially important large pelagic species to study patterns of habitat use and seasonal importance within the Gulf of Maine. The use of popup archival transmitters will not only be used to monitor the baseline distribution of different species that occur in the area but will be able to discern broad-scale spatial patterns in the Western North Atlantic.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Wildlife Computers produces premium-quality equipment that is used in marine species biomonitoring around the world. Their transmitters are configured to work alongside Argos satellites to provide geolocational data anywhere in the world. This combination of equipment will enable our team to track the movement patterns of tagged animals.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The associated costs are based on the quoted amount for one type (MiniPAT-390B) of external transmitter.

Until a similar monitoring system is produced by another company and is more effective, Wildlife Computers is the main provider for this type of transmitter equipment.



