MDMR Division of Sea Run Fisheries and Habitat requires the services of an engineering firm with capabilities and demonstrated experience designing large scale nature like fishways, equivalent to the Howland Bypass, that could be utilized at hydroelectric dams under consideration for passage improvements. This expertise is highly specialized and is essential expertise for considering fish passage at performance levels that are required by the State of Maine. These projects are very high priority and time sensitive.

Interfluve is currently the only firm that has developed large scale Nature Like Fishways at hydro-projects within the State of Maine, including designing the Howland Bypass, the model project for this task to potentially be applied at other sites. Given the tight timeframes and high need, Interfluve is the only provider that can accomplish this task in a timely way.


