The purpose of this agreement is to support the provider in the delivery of Substance Use Disorder (SUD) outpatient (detention center) services to youth up to age twenty-one (21) who are uninsured or underinsured and diagnosed with SUD and currently reside within the youth detention center, Long Creek Youth Development Center. Outpatient services are a critical component of the system of care because if delivered at the appropriate time can prevent a person's condition from worsening, requiring more intrusive and expensive treatment.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Day One is currently the only provider that specializes in the delivery of youth Substance Use Disorder (SUD) treatment in the State of Maine. They have extensive experience in providing this service and are positioned to continue providing these services without interruption.

The Provider provided a budget for review by the Department. The Department has reviewed the budget and deemed the amount fair and reasonable. This amount is consistent with what the Provider received in the prior SFY for youth services and, as agreed upon between the Department and Provider, will remain the same for the 6-month duration of the contract.


