PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

The Department utilizes Bentley EXOR/ALIM (internally referred to as METTRANS) as its Linear Referencing System (LRS). EXOR/ALIM places the Department’s assets in a physical location in space in proper relation to each other on the Department’s transportation network. The system helps reduce costs and improve safety by enabling access to validated and trusted asset data and is foundational to the Department’s ability to report to the Federal Highway Administration (FHWA). Without this system, the Department would be unable to meet its State and Federal reporting obligations and limit its ability to provide services to the people of Maine.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

EXOR/ALIM is highly integrated into the Department’s information systems. The Department needs to continue use EXOR/ALIM until such a time the Department has implemented a different Linear Referencing System. See related response in #4 below.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Continues the rate set in previous extension. This rate is set by Bentley for all Government customers for these services.

4. Describe the plan for future competition for the goods or services.

The Department is currently negotiating an enterprise contract via existing Master Agreement for all services that Bentley provides to the Department. The enterprise agreement will include: AssetWise Inspections for Bridge Inspections, the Enterprise License for CADD and engineering software, and the EXOR/ALIM Linear Reference System.

Bentley is allowing six (6) month amendments for each separate product while a new enterprise agreement is being negotiated. This amendment enables DOT to continue to use EXOR/ALIM through November 2025.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO Maine Office of Information Technology (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
