1.	Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.
	The Department utilizes Bentley AssetWise Inspections Software as a Service (SaaS) to track and report on bridge conditions and inspections. The system is critical for the Department as it helps to meet federal requirements for inspections and asset management mandated by the Federal Highway Administration (FHWA). Additionally, it supports the collection of National Bridge Inventory (NBI) and American Association of State Highway and Transportation Officials (AASHTO) Bridge Components Elements. AssetWise Inspections is a critical component of DOT’s public safety efforts to ensure bridges are maintained and safe.
2.	Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.
	This amendment extends the current contract with Bentley for services Maine DOT procured through a Participating Addendum resulting from TEXAS DOT RFP for Engineering Software Solution Q442014010085000 resulting in contract C442014029958000.
3.	Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.
	Continues the rate set in previous extension. This rate is set by Bentley for all Government customers for these services.
4.	Describe the plan for future competition for the goods or services.
	The Department is currently negotiating an enterprise contract via existing Master Agreement for all services that Bentley provides to the Department. The enterprise agreement will include: AssetWise Inspections for Bridge Inspections, the Enterprise License for CADD and engineering software, and the EXOR/ALIM Linear Reference System.  Bentley is allowing six (6) month amendments for each separate product while a new enterprise agreement is being negotiated. This amendment enables DOT to continue to use AssetWise through November 2025.



## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, Carahsoft OBO Maine Office of Information Technology (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
