PART III: SUPPLEMENTAL INFORMATION

With the passage of the Workforce Innovation and Opportunity Act (WIOA), the Maine Division of Vocational Rehabilitation (DVR) was charged to provide five new services statewide upon request to students with disabilities. These services, called Pre-Employment Transition Services (Pre-ETS), are intended to promote the preparation of students with disabilities to enter competitive, integrated employment in the Maine workforce. DVR is required to report on a quarterly basis to the Rehabilitation Services Administration (RSA) on the numbers of students receiving these services as well as the specific services being delivered. DVR is working with partners across the state to pilot models of Pre-ETS to determine which is the most effective. Goodwill Industries NNE has a track record of providing effective services to youth and has a long-established presence in the Waldo County area.

2. Provide a brief justification for the selected vendor to supplement the response in Part II.

DVR is charged with providing Pre-ETS services statewide but currently has neither the staffing levels nor pre-existing vendor relationships to meet the requirement to provide the needed level of services in the Waldo County area. Specifically, DVR has found the Waldo County area as to be "hard to serve". There are no other state agencies who can provide this service on behalf of DVR. Through this pilot initiative, DVR will serve up to 50 students with disabilities in the Waldo County area.

Goodwill Industries NNE has created a pilot curriculum that delivers all five of the Pre-ETS services.



3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

DVR is proposing a per student fee of \$1500. This fee will cover delivery of the five Pre-Employment Transition Services identified above. Through comparison with similar initiatives being provided elsewhere in the state – and in other states – DVR is confident that this is a fair and reasonable price. Goodwill NNE will leverage other resources to allow for the cost and services to be provided in the most economical way possible.

4. Describe the plan for future competition for the goods or services.

Through this pilot initiative, DVR will serve 50 students with disabilities in the Waldo County area in the coming year. At the completion of the pilot, DVR will assess the feasibility of statewide replication. When that occurs, DVR will also explore issuing a RFP as appropriate.
