Project SHARE has been working with landowners and other partners on a number of high priority restoration projects in the Narraguagus River, Pleasant River, Dennys River and Cathance Stream watersheds. Specifically, they will conduct topographic surveys and fish passage designs with a qualified engineer at fish passage barriers and stream crossings on streams and rivers in consultation with DMR. Where necessary they will provide oversight for agreed upon construction projects.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

As Project SHARE is already conducting these projects with landowner agreements, they are the appropriate and only entity that can conduct this work. Some private land owners of project sites will only work with Project SHARE. Project SHARE has extensive expertise in executing these infrastructure improvements and stream restoration activities within this valuable resource area. Project SHARE has existing funding from other sources to partially implement these projects.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

DMR is providing only partial funding for this effort as Project SHARE has secured or has pending requests for additional funds to make the projects complete. Project SHARE has agreements with qualified contractors and engineers who can complete the project within the agreed upon timeframe and has a proven track record of project completion. This includes many entities that provide their services in-kind or at cost. Project SHARE has an extensive track record of implementing projects in a cost effective and efficient manner in partnership with DMR.

If in the future another vendor becomes available that has the adequate facilities and capabilities to fill this role we will evaluate each equally.


