PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

MDIFW is mandated by statute to “preserve, protect and enhance the inland fisheries and wildlife resources of the Sate; to encourage the wise use of these resources; to ensure coordinated planning for the future use and preservation of these resources; and to provide for effective management of these resources”. As part of this mandate, MDIFW’s Fisheries Division monitors and manages Maine’s inland fisheries species. Fisheries Division staff are working at full capacity and do not have sufficient time to complete all the necessary work during the limited seasonal timeframes in which it can be conducted. Adding additional capacity through this staffing contract will allow the Department to meet its statutory mandate.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the solicitation (RFP/RFA/RFQ) number if applicable.

The vendor has been authorized by the United States Fish and Wildlife Service (USFWS) to use waived overhead for contract administration as cost share match for the Department’s grants. This reduces the state’s cost burden, and we are not aware of any other vendors that are authorized to provide cost share for this purpose.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Salaries are based on equivalent positions at MDIFW. The fee the provider charges for contract administration was negotiated with the Northeast Association of Fish and Wildlife Agencies, of which the Department is a member. The provider waives a portion of the costs to support the Limited Term Employees, which is used to meet cost share obligations to grants MDIFW receives from USFWS.

4. Describe the plan for future competition for the goods or services.

The Department is always looking to save funds. If these services become available from other vendors (providing staff and required grant cost share); the Department would use a competitive process for vendor selection.





Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Inland Fisheries and Wildlife (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind
