<p>Bolduc Correctional Facility needs emergency repair/maintenance to correct fuel leak at injection pump on generator. A generator needs to be on site for power outages while we are awaiting repair. A rental generator is needed to keep facility from freezing and to house and feed the residents at the facility.</p>

<p>The need for a rental generator is urgent. United Rental was contacted first due to their State Contract, but they were unable to provide a generator immediately. A quote and delivery timeframe were then requested from Milton Cat, who confirmed they could have a rental unit on site by the end of the day. Their weekly rental quote was also lower than the rate offered by MA through United Rental.</p>

<p>The services quoted are for emergency rental and slightly lower than the United Rental contract.</p>

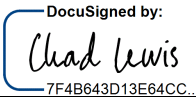

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO Maine Office of Information Technology (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
