PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

Under Title 8, Chapter 35, the Director of the Gambling Control Unit within the Department of Public Safety is charged with regulating sports wagering in the state of Maine. One part of that is licensing a facility, mobile, management service provider or supplier conducting background checks under §1204. These operators and their key personal are much more complicated as some can be nationally and internationally established and operating which require a more in-depth investigation worldwide. Applicants are advised by rule and instructions on the application that a one-time cost for initial background investigation is \$5,000.00 for facility operators and \$10,000.00 for mobile, management service and suppliers. If the cost surpasses the initial deposit amount, the applicant shall be invoiced for the actual remaining balance due which shall be paid before issuance of a license.

This amendment is required in order to continue the services which was not anticipated to have over 40 applicants which we have had.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

Gaming Integrity Services, (GIS) is one of two pre-qualified vendors accepted in an RFP (#202001004) process. GIS along with Gaming Laboratory International, (GLI) were bidders that became pre-qualified vendors. Both were notified by email on July 20, 2020 of the request for services to assist in sports wagering business entity background investigation and GLI responded that they do not provide those specific services. GIS does and have requested consideration.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

Applicants are advised by rule and instructions on the application that a cost for initial background investigation is \$5,000.00 for facility operators, \$10,000.00 for mobile, management service and suppliers and \$2,500.00 for key personnel.

GIS has a professional blended rate of \$212 to \$250.00 for investigations of backgrounds of applicants for licensure.

If the cost surpasses the initial deposit amount, the applicant shall be invoiced for the actual remaining balance due which shall be paid before issuance of a license.

4. Describe the plan for future competition for the goods or services.

A (5) five-year service contract shall be executed for GIS whom, through consultation with the Executive Director, shall provide the background investigations of only initial applications of sports wagering licensees for suitability through national and international operations and activities. This shall include review of any potential conflicts of interest with key executives, directors, officers, partners, shareholders, creditors, owners and associates of the applicant. As well licensees shall be continually monitored for adverse activity by GIS throughout the term of this contract.
