## PART III: SUPPLEMENTAL INFORMATION

1. Provide a more detailed description and explain the need for the goods, services or grant to supplement the response in Part I.

In response to a series of budget initiatives, the Office of Child and Family Services implemented a new three-tiered monthly stipend program for child care workers in November 2023. The level of each tiered stipend was based upon the amount of available state general funds (currently more than thirty (30) million per year) and tier levels differ based upon the child care worker experience and training. The purpose of the child care stipend program is to support the recruitment and retention of a qualified early care and education workforce.

The Department of Health and Human Services, Office of Child and Family Services (OCFS) was awarded a three (3)-year Preschool Development Grant from the Administration for Children and Families at the U.S. Department of Health and Human Services to strengthen Maine's early childhood system. Supporting the child care workforce is a key component of the Preschool Development Grant. As part of the grant, OCFS is expected to conduct an evaluation of this new three-tiered stipend program for child care workers, in order to inform future policy decisions about the structure and funding for this program.

The purpose of this agreement is to conduct a thorough evaluation of the state's new stipend program for child care workers. The evaluation will combine three (3) components: 1) administrative data analysis, 2) survey of child care program leaders, and 3) survey of child care teachers and staff. The provider will test the impact of the stipends via core indicators pertaining to staffing, turnover, and well-being. With the significant state investment in the child care stipend program, an evaluation is needed to determine if the program is helping the state to reach its goal of recruiting and retaining a qualified child care workforce. The provider will produce a final report that will help to inform OCFS, the Children's Cabinet, and the Governor on future policy decisions.

2. Provide a brief justification for the selected vendor to supplement the response in Part II. Reference the RFP number, if applicable.

With the implementation of the child care stipends going into its second (2<sup>nd</sup>) year and to satisfy the requirements of the PDG grant, OCFS needs to leverage the extensive experience and expertise of this provider to conduct this evaluation in 2025. NIU has expert program knowledge and experience with Maine's ECE workforce and child care sector from projects over the past two years. The Provider has successfully supported the Department's ECE division in several projects including building a child care cost estimation tool, analysis of Maine's child care market rates, a fiscal map of the state's investments in early care and education, and an evaluation of the Child Care Employment Award, exceeding expectations, and meeting timelines

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The costs are considered fair and reasonable at \$198,975.00. This evaluation will involve in-depth data analysis and a series of communications with the early care and education workforce to develop a thorough and informative evaluation. The proposed cost of this evaluation contract aligns with other OCFS evaluation contracts such as CFS-24-9100 (\$164,838.) and CBH-22-9003 (\$249,955.)
