The purpose of this Contract is to promote harness racing within Maine, Mix Maine Media is planning to deliver live broadcasts of 28 fair race dates at BANGOR, TOPSHAM, SKOWHEGAN, WINDSOR and FARMINGTON.

Mix Maine Media is the only radio vendor that broadcasts in all of these areas, they will advertise the races on The Mix 107.9, 103.1, 94.1, 95.1 FM, True Country 93.5, 96.1 FM and the Score 1160 AM. Each race will Stream live on all Three Stations websites worldwide via a live streaming service allowing listeners to hear the races from anywhere via their computer or smartphone.

3. Explain how the negotiated costs or rates are fair and reasonable; or how the funding was allocated to grantee.

The actual cost is \$1,000 per day, however, the radio station has secured sponsors to contribute \$250 per day so the total cost to the Harness Racing Commission is \$750 per day which is fair and reasonable considering the length of the broadcast could be 5 hours per day with a 2-man crew.

If the Harness Racing Commissions agree that this provides positive results we may work with other radio stations in southern Maine that can provide service for track in that area of the state.
