The State of Maine seeks to select a vendor/reseller to provide Avaya data network equipment, support and maintenance. The vendor will provide equipment, support and maintenance and limited consulting services for the equipment/network using discount level contract pricing. The State will enter into a master agreement with the selected vendor for a period of three (3) years.

The State of Maine does not guarantee purchase of presented equipment. Avaya equipment and support services purchased may differ from the items presented. The State is using the example equipment scenarios below to select the best value vendor to provide equipment and support service over the 3-year agreement term. The State reserves the right to use the NASPO Value Point Data Communications Products and Services Agreement if pricing is better through that channel.

The agreement must allow for the State of Maine to purchase switches, associated module boards and other related parts separately in varying quantities, complete assembly and configuration locally with no penalty as to cost or support/maintenance level.

Vendors must be an Avaya Platinum Partner able to respond with staff on-site in Augusta, Maine within four (4) hours normal drive time. The selected vendor shall ensure the State of Maine has a valid Avaya Contract ID number and Avaya logon/user account with software download permissions for all contracted maintenance items. All equipment must be covered by an Avaya backed GF6300 Service Contract, or GF4300 Service Contract with a 24x7 NOC staffed with Avaya Networking Certified Personnel.

All equipment must be delivered within 14 business days from the receipt of an order. All shipping and handling cost for delivery to Augusta, Maine must be included at no additional cost. The State may pay for equipment via purchase/delivery order or credit card. No credit card surcharges will be allowed.

#### Maintenance and Warranty

All units must come with a repair or replace and upgrade service, and all units must be automatically added to a maintenance contract in accordance with the specified maintenance levels. Maintenance costs must be prorated to the end of the Contract. The Avaya maintenance contract rate must be made available to the State of Maine to add existing supportable Nortel/Avaya equipment to maintenance coverage.
