only one day. If they are not able to obtain additional medication quickly, they are at risk of post-release drug overdose. This also leaves considerable gaps in their ability to remain in recovery and treatment.

Franklin County Detention Center (FCDC) seeks to offer XRB to all residents with OUD still in custody after arraignment using the rapid initiation process developed by Somerset County Jail. FCDC anticipates that approximately nine residents per month will be eligible for XRB.

Somerset County Jail in Madison implemented an XRB program about 3 years ago under the leadership of their director of addiction medicine, Dr. Alane O'Connor. She is the state's leading medical provider for MOUD best practices in jails. Dr. O'Connor and Sheriff Lancaster developed workflows, medical protocols and systems level change to offer XRB. Despite XRB's efficacy and tolerability, its cost (\$1,633/injection) is a major barrier in correctional settings. FCDC's COSSUP grant does not allow for funds to be used for the purchase of medication. Funding from this DPS grant would provide sufficient funding for FCDC to offer XRB to all its residents for one year. Offering XRB will support the rehabilitative philosophy of the Sheriff and align with the COSS UP in house programing and reentry services.

FCDC working with Dr. O'Connor who has had success with a similar project for XRB is a good partnership and her experience will be very beneficial to this project.

Grant funding from different sources will be used simultaneously, not sequentially, as some have restrictions (e.g., DPS RSAT can be utilized only to purchase XRB for individuals incarcerated 90 days or more) and each award has a unique contracting process and timeline.

Somerset County Jail has received funds from DPS RSAT Grant for the purchase of XRB medications. RSAT grant provides approximately \$455,000 to SCJ through 9/30/2026. Funds cover 35 injections per month for individuals who have been incarcerated for 3 months or more.
