Award Justification Statement RFP# 202405101 Blue Economy Task Force Project Management and Subject Matter Expertise

I. Summary

The State of Maine sought proposals for a qualified professional firm to assist with staffing of the State of Maine's Blue Economy Task Force, per S.P. 523 – LD 1286, Resolve, to Establish the Blue Economy Task Force to Support Maine's Emergence as a Center for Blue Economy Innovation and Opportunity in the 21st Century. With oversight and strategic direction provided by the Department of Economic & Community Development's Office of Business Development, the staffing will include project management, subject matter expertise in blue economies across the globe, adherence to the statute, and preparation of a report to the 132nd Legislature in 2025.

II. Evaluation Process

The Office of Business Development's Director comprised a team of three individuals to review proposals. The evaluators included a business development manager specializing in small businesses and innovation, a marketing, communications, and legislative specialist, and a market attraction leader with previous substantial experience in public procurement within the State of Maine. The evaluators applied the consensus method in scoring the Bidders Qualifications and Experience and Proposed Services. Scores for the cost proposal were assigned using a mathematical formula.

The successful bidder's previous experience showed clear relevance to the goals and purposes of the RFP. The past projects demonstrate success in the following areas:

- Strength of organization and previous experience, particularly with blue economy
- Strength of team, including data, blue economy expertise, project management, and innovation
- Scope of services, thoughtfully described and in alignment with the RFP
- Thorough work-plan and timeline in alignment with the RFP and statutory requirements.

IV. Proposed Services

The bidder's experience and qualifications in blue economy, project management, and economic baseline work, as well as their thoughtful and well-constructed approach and work plan yielded high scores for their proposed services and scope of work.

Dr. Walton does have international blue economy experience, but it is mostly policy-related, specific to international policies and agreements.

Previous project experience: "A notable example is my involvement in a project that used satellite data to monitor and manage marine protected areas effectively."

Investments made by MVF aren't direct experience in developing blue economy strategy.

Projects listed aren't directly related to the scope of work described in the RFP.

A. Services to be Provided

Detailed work plan broken down into tasks, but no specific example of the entities to be consulted; work plan isn't presented in a way that shows the consultant knows the industry or players well.

This is not as important as following the procedure outlined in the statute, although good project management methods are important.

Overall, these details are quality over quantity.

B. Implementation – Work Plan

- Clearly define what success looks like for each task and deliverable, including specific, measurable, achievable, relevant, and time-bound (SMART) criteria. This is a good tactic.
- Establish benchmarks and key performance indicators (KPIs) to track progress against these criteria. The requirements of the statute are more important than other defined KPIs by the consultant, however.
- Timeline doesn't match up with the RFP or statute.
- Bar graph isn't a good format for showing this

Definitions generally contain mixtures of three elements: (1) the portion of the economy measured by output and employment that is related to the ocean; (2) the parts of the economy that develop and deploy new technologies related to the ocean; and (3) activities related to the conservation and restoration of ocean and coastal resources that maintain or increase the natural capital on which other 2 activities depend. Each of these will be inventoried in Maine and compared with national and regional trends to assess Maine's competitiveness."

Shows that they have already moved through the process and are ready to hit the ground running. This is an good example of taking initiative.

Proposes doing consultations outside of regularly scheduled meetings. The industry participants might not be okay with that.

Light on details but the visual timeline is well done and really highlights when meetings are happening and what month each task will highlighted. Details would have been nice. Seeing more information under each task would have given more intel into how they plan to move through the process.

Unique considerations for Maine including geographic diversity:

"Approach: Tailored data collection and analysis methods will be necessary to capture the full range of geographic diversity. This might involve region specific surveys, localized data collection efforts, and distinct analytical models to account for the differences between coastal areas."

The statute does not reference region-specific surveys. I like this idea, but it's up to the Task Force to decide.

They reference addressing economic disparities, while this isn't in the statute. "This includes focusing on workforce development, equitable access to resources, and support for small and medium-sized enterprises (SMEs) in the blue economy."

"Necessitating a more nuanced approach in Maine to ensure equitable development across all coastal regions."

Nowhere did we say we wanted development across all coastal regions. That is almost the opposite of the way things work in Maine.

Their approach does not include Consultation as described in the statute and in the RFP, this is the bulk of the work needed.

"Creating two types of agendas for each meeting 1) a general public agenda and 2) a detailed annotated agenda for internal coordination. OBD will approve all final agendas." It was never mentioned that agendas would be public in the statute or RFP. Whoever has prepared this is assuming this would be like other task forces they've worked on (e.g., Climate Council).

They've suggested meeting reports – once again, this was not listed as a task in the RFP. Notes for the meetings are sufficient.

members, and marine economy representatives."
