The Environmental Analyst (EA) returned the call on 1/3/2024 at 2:01 PM and explained that the sludge odors may be coming from trailers delivering sludge to the landfill and waiting in line to unload and/or from the handling of sludge within the landfill. The caller mentioned that he was not happy with the odors as he "lived there before the landfill and it never used to be like this." JRL staff will continue to ensure that sludge deliveries get covered adequately and as quickly as possible.
