The caller stated that he experienced mixed landfill odors at his residence at $9:00$ AM. The Environmental Analyst (EA) called the complainant on $3/10/2025$ at $9:21$ AM and left a message but did not receive a call back. A drive on Route 43 to the Kirkland Road was conducted by the EA on $3/10$ at $10:20$ AM, who noticed a faint odor of H_2 S on Route 43 south of the landfill. The odor was not confirmed near the Kirkland Road. The EA commented that the odor was likely from operational trash placement on top of the landfill. RL personnel have been working to remove the soil cover material on top of the landfill in preparation for waste placement for the Stage 3 Final Cover project. This likely contributed to the odor. JRL staff will continue to place daily cover material at the end of the workday to help minimize odors.

JRL staff conducted a drive on Route 43 to the Kirkland Road on 3/13 at 7:35 AM. The odor was not confirmed near the Kirkland Road. The wind direction at the time of the site visit was ENE at 3 mph. JRL personnel have been working to remove the soil cover material on top of the landfill in preparation for waste placement for the Stage 3 Final Cover project. This likely contributed to the odor. JRL staff will continue to place daily cover material at the end of the workday to help minimize odors.

JRL personnel have been working to remove the soil cover material on top of the landfill in preparation for waste placement for the Stage 3 Final Cover project. As the complaint occurred during the landfill's operational hours, it is likely the landfill contributed to the odor complaint. JRL staff are working as quickly as possible to place waste in the open area and replace cover material in an effort to minimize odors.
