JRL staff continue to add daily cover and make daily improvements to the landfill gas system to minimize odors.

He stated that it "smells like the landfill, nothing else smells like it." No other details were given. The caller did not request a call back or a site visit. JRL operations staff were notified. At the time of the complaint no off-site H2S monitors picked up any low level H2S readings. It is unknown if the odor source may have been the landfill. JRL staff continue to add daily cover and make daily improvements to the landfill gas system to minimize odors.

No other details were given. (EA) called the complainant at 1:55 PM on 4/5/ 2024 regarding the complaint. The EA explained that a considerable number of sludge deliveries had occurred and the extremely wet weather likely caused an increase in odor at the landfill. The EA notes that the odor at the landfill was verified by JRL staff. JRL staff continue to add daily cover and make improvements to minimize odors.

The EA returned the phone call on 4/18/2024 at 9:43 AM and spoke with the complainant's wife. The EA told her that the odor at the landfill was confirmed and being investigated by JRL personnel to find the source. JRL staff continue to add daily cover and make daily improvements to the landfill gas system to minimize odors.

The caller stated that they experienced "sludgetype odors" at their residence at 4:30 PM. The caller requested a call back on 4/25/2024, but no site visit. At approximately 5:00 PM on 4/24, a member of JRL staff drove to the caller's address and parked nearby for 10 minutes to verify the odor complaint. At the time the wind direction was out of the southwest at 1.1 mph. When JRL staff performed the site visit, the wind direction had shifted to out of the northwest; therefore, the staff person did not detect any sludge odor and the presence of the odor could not be verified. JRL staff will continue to add daily cover to help minimize odor.
