The Environmental Analyst (EA) had been at the JRL facility all day on 12/01/2023 for training and had experienced some landfill odors throughout that day. The JRL pipe crew had been working to prepare areas for the installation of new gas collection piping. Their work included digging trenches to lay pipe in and the trenches may have been responsible for the emission of landfill gas odors. The EA returned the phone call on 12-02-2023 at 9:37 AM and left a message on the caller's answering machine. In the message, the EA explained that JRL personnel were investigating where the landfill gas odors were being emitted and working to take the appropriate measures to mitigate odors.

The EA explained to the caller that work was not a significant health risk. The EA further explained that the landfill may also be getting sludge deliveries which can carrying sludge odors beyond the landfill property. A letter was sent to abutters on 12/7/2023, advising them that work at the landfill (new gas well drilling) would heighten H2S odors while the work was being conducted.

A letter was sent to abutters on 12/7/2023, advising them that work at the landfill (new gas well drilling) would heighten H2S odors while the work was being conducted. This caller had been advised of the well drilling work on the evening of 12/6/2023, during a meeting with the JRL advisory Committee, which he was in attendance of.

The EA left the residence and went to JRL to speak with staff about making sure that sludge deliveries get covered adiquately and as quickly as possible.
