JRL staff were notified and will continue to do their best covering odiferous waste as it comes in and before the end of the workday.

JRL staff will continue to do their best covering odiferous waste as it comes in and before the end of the workday.

JRL staff have been investigating the causes of bad sludge odors at the landfill in an effort to reduce off-site odor complaints. JRL staff will continue to do their best covering odiferous waste as it comes in and before the end of the workday.
