#### e4h Project No. 2020090 Addendum No. 1

This Addendum forms a part of the construction documents and modifies the original Issued for Bid dated July 14, 2023. The enclosed additions, deletions, corrections, and changes will be as binding as if incorporated in the original documents.

## Questions:

- 1. I see completion dates in the specs but is there an anticipated start date for this project?
  - a. A construction contract is expected to be executed as soon as practicable following the contract procurement process.
- 2. The drawings call out thru wall flashing but does not indicate metal or flexible, what kind of flashing is wanted?
  - a. Thru Wall flashing at the base of wall should be prefinished Metal Flashing Minimum 26 Gauge, color to be "Dark Bronze" – Submit all metal trim samples to architect for approval prior to fabrication.
- 3. I see AISC certification is needed for steel fabrication. Can AWS certs be substituted?
  - a. No, that is not an equivalent substitution. AWS only qualifies the welders on the project, where AISC certifies the entire fabrication process.
- 4. I see all of the lab casework is to be stainless steel. However, the fume hood specs note painted steel construction. Please confirm that painted steel fume hoods are acceptable or should we price as stainless steel?

# a. The fume hood will also be required to have a stainless steel finish to match the lab casework

- 5. Will the materials impacted by this building demolition be tested for asbestos? If so, please issue the testing results from the building impact survey.
  - a. Hazmat Testing Report (8 Jan 22) was included in Specification Vol I, Appendix A. Additional Hazmat Report pertaining to the Boiler only is attached to this document
- 6. In the fire alarm spec it mentions Honeywell Notifier. Will a Simplex fire alarm panel be accepted as well?
  - a. The panel the State of Maine has standardized on is Honeywell XLS 3000; no substitutions.

# Changes to Drawings:

- 1. Drawing "A1.10A Floor Plan First Floor Area A"
  - a. Room "110 TELE/COMM" Room to have a 1 hour rated partitions on all (4) four sides, with door #110 to be labelled w/ 45-minute rating.

### Changes to Specifications:

1. **Omit Section "113013 – Appliances"** –Existing appliances will be relocated from existing building.
