Response: All permitting for project has been obtained. No further permitting is required. Contractor will be required to contact Dig Safe prior to commencement.

2. Just to be clear the bid when it is ready is going to a secure email @ BGS.Architect@Maine.gov ? it lists that there is no bid bond required and lists that a Performance and Payment Bond is required. Do you want this performance bond included in the is bid package or only after if we are low bid it gets sent to you after the bid opening and contract docs get signed.

Response: Bid bond is not required for the project. Performance and Payment Bonds will be required prior to executing project contract.

3. on page 32-23-23 -3 of the contract docs. Its lists as the dense crushed aggregates being tested by the L.A Wear Test Testing Procedure. We want to make sure that if we are placing a bid for this project that all contractors will be held by this highest standard material testing if awarded the contract and we all following this same specific specification as we place our bids for this project.

Response: The specification in question is found on 31 23 23 – 3 #4 Dense graded crushed aggregate subbase.

Disregard the testing requirements:

When tested by the Los Angeles Wear Test, the percent loss shall not exceed 25. The material will be tested before being used and retested at intervals of approximately 25%, 50%, and 75% completion of the course.

All other specifications in this section are to be included in the project.
