*The construction project scope includes: Select CMU removals & repairs, protection works, concrete slab cutting-, removal- and replacement, some sub-grade hand excavation & minor existing drainage pipe repairs, suspended acoustic tile ceilings, resilient sheet goods flooring-, painting-, phenolic black core toilet & urinal partitions, ADA accessories, hollow metal doors-, frames- & hardware, toilet partitions, rough-in-, modifications-, plumbing-fixtures, mechanical upgrades, LED lighting- & electrical-upgrades, and some alternate bid architectural finishes, all in existing spaces.*

The cost of the work is approximately \$ 280,000. The work to be performed under this contract shall be completed on or before the Final Completion date of 27. August 2021.

The envelope shall contain a completed Contractor Bid Form, plus bid security when required, to be received no later than **2:00 p.m. on March 25, 2021**. Bid submissions will be opened and read aloud at the KVCC Carter Hall Multipurpose Room, 92 Western Avenue, in Fairfield, Maine 04937, East Entrance (COVID-19 Checkpoint Station), please allow sufficient time to fill out a COVID-19 Visitor's Declaration form and have your temperature taken by KVCC Campus Security. Bidders are advised that face masks are required by KVCC and the Maine Community College System, at the time and date noted above.

Any bid submitted after the noted time will not be considered a valid bid and will remain unopened. Any bid submitted by any other means will not be considered a valid bid.

2. The bid shall be submitted on the Contractor Bid Form (section 00 41 13) provided in the Bid Documents. The Owner reserves the right to accept or reject any or all bids as may best serve the interest of the Owner.
3. Bid security *is required* on this project.  
If noted above as required, the Bidder shall include a satisfactory Bid Bond (section 00 43 13) or a certified or cashier's check for 5% of the bid amount with the completed bid form submitted to the Owner. The Bid Bond form is available on the BGS website.
4. Performance and Payment Bonds *are required* on this project.  
If noted above as required, the selected Contractor shall furnish a 100% contract Performance Bond (section 00 61 13.13) and a 100% contract Payment Bond (section 00 61 13.16) in the contract amount to cover the execution of the Work. Bond forms are available on the BGS website.
