The following items consist of information discussed at the Prebid Walkthrough and will be considered part of the requirements for execution and performance on the project.

As a result of the requirement that this conference be mandatory, bids will only be accepted from General Contractors in attendance.

- Everyone met and signed in. The scope of work was described and then the rooms affected were toured. LVT is being installed over existing ACT. Loose ACT should be replaced before overlaying new LVT.
- 2. The building will be occupied during the course of the renovation. Phasing and weekend work is shown on the plans to allow some areas to not be impacted by corridor closures. Phasing is conceptual, and revisions proposed by the Contractor would be considered. Phases do not require separation partitions.
- A GC superintendent must be on site when work is being done. The superintendent and key
 personnel will be able to have access cards issued to them. Badges will be required for after hours
 or weekend work.
- 4. The Owner will strip the was from the floors. If scarification is needed the GC can provide that.
- 5. Some areas have been shown with bush hammering to remove deteriorated concrete.
- 6. LVT colors have been selected and were in production recently.
- 7. Noise and vibration work and shut-downs must be cleared in advance with 24 hours notice. No flames or heat guns to be used.
- 8. Job site shall be quiet and orderly. No music. No smoking anywhere.
- 9. Vending machines will be temporarily relocated by the Owner. Provide advance notice.
- 10. The double doors to the tunnel and some flooring in that location are being replaced by another contract. Coordinate work in the area.
- 11. There will not be space inside the building for storage of materials. Coordinate site storage and parking with the Capitol Police.
