# **GENERAL**

Included with this Addendum are the Pre-Bid Meeting Minutes from August 27, 2024.

Answers to Questions that have been asked:

- *Q*: Will the Owner consider a bid extension?
- A: Yes, the Bid Schedule has been extended as follows. See the revised Specification Section 00 11 13 Notice to Contractors attached to this Addendum.
  - Questions and Comments will be due at 5:00 PM on Monday, September 16, 2024.
  - Bids will be opened at 2:00 PM on Thursday, September 26, 2024.
- *Q*: What is the Engineer's cost estimate for this project?
- A: There is not an Engineer's cost estimate to be shared for this project.
- Q: The Workshop, Entrance Booth, Vault Toilet, and new pavement are shown as alternates. Is there any other scope of work that is part of the alternates that is not described?
- A: No. The Bid Alternates should include the scope of work, as indicated on the Contract Drawings.
- Q: Will the Alternate Bid be awarded with the Base Bid or is there a possibility the Alternate may not be awarded with the Base Bid?
- A: The Bids will be awarded based on priority. There is a possibility that the Alternates may not be awarded with the Base Bid.

- Q: Is horizontal directional drilling and/or pipe bursting allowed for any part of this project?
- A: No, horizontal drilling and/or pipe bursting are not allowed for this project. Water piping must be bedded in sand as shown in the Typical Trench Detail on Sheet C501.
- Q: Plans call for a "standing seam" metal roof. We can offer a similar product considered "hidden fastener" metal roofing. These snap lock panels are sourced from ware butler rather than being fabricated on site. They function similarly and do not have exposed fasteners. Would this be an approved equal.
- A: No, hidden fastener metal roofing will not be considered an approved equal for this project.

The Work shall generally consist of facilities and utilities upgrades at Swan Lake State Park in Swanville, Maine. The Work shall generally include installation of new conduit for fiber data service, demolition of the existing outhouse structures, construction of a new bath house with associated septic system, installation of new water distribution mains with necessary valves and appurtenances, electrical upgrades to an existing day-use shelter, and relocation of existing playground equipment. #### P. QUESTIONS

Questions received during the pre-bid meeting are answered herein.

# Q: Is any of the existing playground equipment set in concrete? If so, how much of the existing concrete/equipment should be moved?

A: Yes, the existing swing set is anchored within an undetermined amount of concrete. Contractor shall field verify the existing playground conditions. It is the intention of the Owner to move as much useable existing equipment and materials as possible. Contractor shall include cost for complete relocation of the existing playground in the Base Bid. New materials or equipment necessary to complete the relocation are incidental to this Work.

# Q: What is the plan for demolishing the existing changing/outhouse structures and vault toilet?

A: Contractor shall demolish the existing structures to grade. The existing vault shall be pumped out and thoroughly cleaned. Once the vault has been cleaned, Contractor shall break the walls in and backfill the remaining excavation to grade with gravel.

# Q: Is tree clearing necessary for playground equipment relocation?

A: It is not the intent to clear trees for the relocation of playground equipment. Contractor is encouraged to utilize existing open space to the extent possible while ensuring that the relocated playground equipment is outside of the 250-ft shoreland zone setback. Provisions for tree clearing shall be considered during Construction.

#### Q: Has the project obtained any permits?

A: Yes. The following permits have been obtained or are in the process of being obtained for the project: 1) Demolition Permit, 2) Building Permit, 3) Septic Design, 4) State Fire Marshal Construction Permits (Bath House, Workshop, and Entrance Booth).

# Q: Is water quality testing required by the Contractor?

A: Yes, water quality testing is required by the Contractor.

# Q: Is it the Contractor's responsibility to replace the wooden road crossings along the utility corridor?

A: It is the Contractor's responsibility to restore the existing conditions along the utility corridor. Contractor may reuse the existing road crossings and re-set them during backfilling.

# Q: Are there any provisions for rock removal?

A: No, there are no provisions for rock removal for this project. It is not anticipated that ledge will be encountered during trenching or excavation.

# Q: There is an existing large pine tree nearby to the existing entrance booth. Will it need to be removed for the road widening?

A: It is not the intent to remove the existing pine tree. Contractor shall preserve the tree during road widening to the extent possible.

# Q: Is the existing entrance booth foundation remaining for the proposed entrance booth?

A: No, the existing entrance booth foundation should be demolished as part of the complete demolition of the existing structure.

# Q: Is an Engineer's opinion of cost available for this project?

A: No, there is not an Engineer's opinion of cost available for this project.

#### Q: How are cables to be routed at the shelter?

A: Cables shall be run in EMT on the surface of the shelter's structure. All visible conduits shall be painted to match the surface they are run on.
