Addendum 1: Bid Clarifications and Responses to Bidder Requests for Information (pre-Bid RFIs)

Sebago Lake State Park Parking Lot Upgrades, Boat Launch, and Campground Upgrades BGS project number: 3637

Bidders are to prepare bids based on the following responses to pre-Bid RFIs, and Additional Clarifications:

RFI 1: Will the utility be supplying and setting the transformers & connections to transformers? **Response:** CMP will provide and set transformers. Contractor to perform all connections.

RFI 2: Please confirm the sites to be included in Alternate #1. There are contradictions between the outlined area of Dwg. CD-162, note 1 of Dwg. CD-162 and the one-lines on Dwg. E-561

Response: The outlined area is not correct on CD-162. Note#1 on CD-162 and the one line diagram on E-561 are correct.

RFI 3: Is there a size Type that should be assumed for the electrical handhole, as shown on Dwg. C-562, Detail 4.

Response: Assume the largest handhole size for bidding purpose, type 9.

RFI 4: Dwg. E-561 calls for 3.5" conduit with 600kcmil for the service connection between the riser and the transformer/cabinet(s). Note #4 on the same drawing calls for a #2 wire service in 2.5" conduit, with 2.5" also being noted as Item #11 on Dwg. C-162 & C-163 . Please confirm which is correct. If #2 in 2.5" conduit is correct, please identify where the secondary feed is supplied from to create the loop feed requested.

Response: Note #4 indicates the cable and conduit size to use for the high voltage underground system between the utility pole and the loop system through the transformer high voltage line side. The 3.5" conduit with 600 kcmil size indicates the conduit and cable size to use between the transformer load side and panel MDP.

RFI 5: Provided the amperage and quantity of the circuit breakers for each panel, the anticipated panel size will be too large for the specified cabinet size. Should a larger cabinet be provided to fit the larger panel or should room for future breakers be reduced to fit inside the specified cabinet?

Response: See sheet E-561 for amperage and quantity of circuit breakers for each panel; no spare circuit breaker is required. Each branch circuit breaker is a 2 pole 240V 60A breaker. Provide panelboard with a maximum of 42 circuits.



RFI 6: Specification 015000 requires the contractor to rent a field office for the project. Is this necessary given the short duration of the project?

Response: Rental of a field office is not necessary.

RFI 7: Specification 015000 3.4 E. requires excavations to have enclosure fences. Is this necessary if excavations are backfilled at the end of each day?

Response: Enclosure fences are not necessary, provided excavations are backfilled at the end of each workday.

RFI 8: Campground Upgrade Alternate ... the plan has an alternate to upgrade additional camp sites along with the ones labelled as base bid. The Bid form only has one alternate for campground upgrades which I assume is the whole volume 2-5 planset. How is the alternate within the plan set to be priced?

Response: A revised bid form is attached, and is to be used for bidding; base bid will be for 32 hookups, and Alternative Bid 1 is for the 6 additional hookups (demo and construction).

Additional Specification Clarifications:

1. Snow Plowing and Sanding is to be bid as an Alternate Bid; refer to revised Contractor Bid Form.
