- A1 The work requires stripping in the EPDM field seams on Roofs E and D in accordance with the Legend on Drawing A101, Detail 8 on Drawing A702 and Specification Section 07 53 00 Elastomeric Roofing and Flashing.
- Q2 (Ref. 1/A101) Confirm existing Roof area G is flat seam copper.
- A2 Roof Area G does include flat seam copper panels with fully soldered seams.
