This addendum is issued prior to receipt of the bids and does hereby become a part of the contract documents, and in case of conflict, it shall supersede the original project manual and drawings.

Each bidder shall be responsible for issuing information contained herein to sub-contractors and suppliers to ensure that their proposal covers all work required by the contract documents including this addendum.

GENERAL

- 1. All questions must be submitted in writing to Oak Point Associates, attention Leah Schaffer. Email: Ischaffer@oakpoint.com. All clarifications will be sent out by written Addenda.
- 2. Sign-In Sheet for the Pre-Bid Meeting held on January 14, 2025 is attached.
- 3. The Geotechnical Report is included in the Project Specifications in Section 312000 Earth Moving as an attachment.
- 4. As a General Note Room numbers will be clarified in the Ready for Construction set.

QUESTIONS RECEIVED

The following are questions received during the Pre-Bid Meeting on January 14,2025 and responses are as follows.

- Question: Can you confirm working hours for the project and if off hour work is allowed?
 - a. See Phasing Plan General Note 1 and 2 on G-109 and Specification Section 011000 Summary 1.11 B. Working hours are to be Monday through Friday from 7:30am to 5pm except Government holidays. Prior written approval from Owner is required for off hours work. Work in the State House is to be scheduled after Legislative adjournment in June. All work on the 7th Floor will need to be completed during off-hours.
- 2. Question: Are there any known hazardous materials?
 - a. There are no known hazardous materials at the Cross Building. Lead Paint is suspected at the existing plaster ceiling of the State House. See General Note 3 on AD104 and General Note 4 on AE703 for testing required by contractor.
- 3. Question: When is Substantial and Final completion expected?
 - a. See Notice to Contractors included in Project Specifications. The Substantial Completion Date should be on or before June 30, 2025 for the Capital Police Offices, and 15 December 2025 for the two Security Screening areas, and the Contract Final Completion Date on or before 15 January 2026.

- 4. Question: Is there a location noted for dumpsters on Site? Can debris be brought down the elevator or the stairs?
 - a. The contractor laydown area is noted on CX101 in a portion of the parking lot and the dumpster should be located within this area. Debris can be transferred via stair or elevator provided floor and finish protection is provided. For Basement removals, only one elevator has basement access and card access will need to be requested from the Owner.
- 5. Is the General Contactor or the demolition contractor to carry the cost for floor/finish protection?
 - a. Floor and finish protection during demolition is to be provided through work areas and where debris will be carried through occupied spaces. The cost for these items should be coordinated between the demolition subcontractor and General Contractor.
- 6. Will the Owner remove furniture and equipment from work areas?
 - a. The Owner will remove all furniture, wall mounted artwork, and moveable equipment from areas of work unless noted otherwise on demolition drawings. The existing Key Boxes will be removed and relocated by the Owner prior to construction start.
- 7. How will access be provided to the building and specific work areas?
 - a. General Contractors and subcontractors will be provided with access cards to specific building areas as required during the associated construction phase. Background checks must be passed prior to issuance of access cards. Prior Notice is to be given by the contractor to Building Controls at least 24 hours prior to access being required.
 - b. During normal working hours of 7:30am to 5pm Monday through Friday the building is open to the public. Access on weekends and after 5pm on weekdays will require advanced notice of 72 hours for Building Control and Capital Police to coordinate.
- 8. Are background checks required?
 - a. Background checks are required for all General Contractor and subcontractor personnel that will be on site. Background checks will be run by Building Controls at no cost. If failed personnel will not be permitted on State grounds.
- 9. Do we know the existing first floor slab thickness?
 - a. The existing slab is +/- 7" thick and is noted on SF103 and AD101. Original Construction drawings from 1954 have been provided for reference as well as an attachment to this addendum.
- 10. Will the veneer on the addition match the existing?
 - a. Yes, the addition will have 3-5/8" thick granite veneer panels. The existing stone is Deer Isle Granite. See Specification Section 044200 and drawings for additional information.
- 11. Are any of the existing doors ballistic rated?
 - a. None of the existing doors to be removed are ballistic rated.
- 12. Where are security systems located?
 - a. For the Cross Building security items are located in Room T12 and T11.
- 13. Will any work be completed in the Main High Voltage Electrical Room at Cross?
 - a. No work will be needed in the high voltage electrical room. Work on the first floor of the Cross building is at Elec 140 and 112 electrical rooms only.

- 14. Does the ACT ceiling on the 7th Floor need to be reinstalled at the end of each working day?
 - a. No the ceiling can remain down for the duration of work needed on the 7th Floor and reinstalled once work above the ceiling is completed.
- 15. How much space is above ACT ceilings in the Café and Dish Area?
 - a. There is approximately 18" from ACT ceiling to bottom of steel beams and 30" from ACT ceiling to structural slab.
- 16. Is the structure for the existing building or the addition required to be blast rated?
 - a. No the structure is not required to be blast rated. The new windows noted as Type A are required to be UL Level 3 Ballistic Rated. Interior Storefront systems, interior storefront doors, and interior doors for both buildings are required to be UL Level 3 Ballistic Rated where scheduled.
- 17. Can a Bid Extension be provided?
 - a. Please see reissued Notice to Contractors for Bid questions and deadline extension.
- 18. Is access control required for Door 138A and 138B at the State House with the pivot hinge this does not seem feasible?
 - a. These doors are being replaced with UL Level 3 Ballistic Doors with continuous geared hinges. Access control is to be provided at Door 138B. See Door Hardware Specifications 087111 and Electrical drawings for additional information.
- 19. Does the Owner have a preferred contractor for Utility locating services?
 - a. There is not a preferred contractor for Utility locating. Centerline Utility Services previously marked utility locations in the field as they are noted on Civil drawings.
