

ADDENDUM No. 2 – IT Networking Equipment Bids - New Morse High School & BRCTC

To: All Interested Bidders

All items in this Addendum shall supersede or clarify the Bidding Documents as originally issued. The cost of the Work of all equipment vendors affected by the changes in this Addendum shall be included in the Base Bid or Unit Prices, as applicable. Failure to do so may subject the Bidder to disqualification.

This Addendum forms a part of the Bid Documents; including Addendum 1 Items 1 through 5. It supplements and/or modifies them as follows:

Item No. 6: Specification 00 21 13 Instructions to Bidders:

Paragraph 2.02G: Add the following paragraph:
“Bidders not on the “Pre-Approved Contractors” shall provide the “supplemental qualification documents” with the bid submission.”

Item No. 7: Specification 00 21 13 Instructions to Bidders:

Paragraph 2.02H: Add the following paragraph:
“A Bid Bond, Performance Bond and Payment Bond are not required.”

Item No. 8: Specification 01 00 00 General Requirements:

Paragraph 1.02B1: Add the following paragraph:
“Bidders shall include the cost of a lift for the WAPs that require installation at heights 14ft and 26ft. Bidders shall include this cost as a separate line item within the Bid.”

Item No. 9: Specification 01 00 00 General Requirements:

Paragraph 1.02B2: Add the following paragraph:
“The Owner does not need any configuration of the devices or equipment; except for the configuration of the WAP devices and controller required to be installed by the successful bidder.”

Item No. 10: Specification 01 60 00 Product Requirements:

Paragraph 1.03B1: Add the paragraph as follows:
“The successful bidder shall be provided with drawings showing the WAP locations. The Owner’s General Contractor is installing all wiring and terminations for all WAP locations. WAP mapping is not required as part of the bid. The successful bidder will be required to provide the mapping as part of the Work.”

Item No. 11: Specification 01 60 00 Product Requirements:

Paragraph 1.03E: Add the following paragraph:

“Bids shall include one (1) exterior-grade WAP. Bidders shall include a recommended SKU for this item consistent with the quality of the specified interior WAP devices.”

Item No. 12: Specification 01 60 00 Product Requirements:

Paragraph 1.03F: Add the following paragraph:

“Wireless access points, as listed in the Specification shall be used in the both gymnasias and the Performing Arts Center (auditorium) use; specifically, the Aruba AP-345 WAP for coverage in these high-density areas.”
