Question: We are wondering if you are going to change the completion date for the BABLO roof replacement project in Hallowell? Could this project be completed in Spring of 2020? Response: The project completion date will not be extended beyond the advertised current final completion date. Is this project FM insured? There is a lot of FM wording in the spec and I want to know if the Question: project is FM insured. <u>*Response:*</u> The project is not FM insured. Question: If the project is not FM insured, can we follow an FM Roof Nav assembly that is the same as the specified assembly and provide lesser attachment rates for insulation and cover board that meet the uplift requirements (2.1.C) and warranty requirements (1.11)? Yes. <u>Response</u>: Question: Please confirm intent to specify "Resista" type coated glass facer polyiso insulation (ATSM C-1289, Type 2, Class 2, Grade II (2.6.B). Standard glass mat polyiso is acceptable in the FM Roof Nav assembly and meets the requirements for the specified warranty (1.11). Please clarify which type of polyiso is intended. <u>Response</u>: Provide specified insulation type. Question: AE121 shows tapered insulation with "a minimum average r30 insulation value be maintained. Please clarify if a minimum r30 is required or if an average r30 is required. You can specify either 'minimum r" or 'average r" both not both.

<u>Response</u>: Drawing note will be revised indicating to provide 'minimum R30'.

Appeal - Any person affected by the determination of these rates may appeal to the Commissioner of Labor by filing a written notice with the Commissioner stating the specific grounds of the objection within ten (10) days from the filing of these rates with the Secretary of State.
