#### **GENERAL**

- 1. Unless otherwise noted, salvage and return to Owner existing fire alarm devices and appliances shown to be removed but not shown to be reinstalled.
- 2. A square edge with laminate is acceptable for the curved library desk.
- 3. A Die wall construction on the Library Reception Desk is acceptable to allow for this unit to be constructed at the millworkers shop.
- 4. The maple in the library is to be natural finish with polyurethane.
- 5. There will be no charge for water and electricity utilized in the construction of the project.
- 6. Moisture tests at new slab placements will be required prior to the installation of flooring.

#### Renovations to 400 Wing and Library at the Washington County Community College

The project consists of the renovation of the 400 wing and library at the WCCC facility. The construction consists of steel structure; building insulation; doors, frames, and interior aluminum curtainwalls; interior partitions; finishes; and modifications and improvements to existing fire suppression; mechanical and plumbing; and public address systems including incidental work.

The cost of the work is approximately \$ 1,000,000. The work to be performed under this contract shall be completed on or before the Final Completion date of *14 August 2020*.

Any bid received after the noted time will not be considered a valid bid and will remain unopened. Paper bid submissions will not be accepted, however, bidders may be required to surrender a valid paper copy of the bid form or the bid security document in certain circumstances.


