Subject: Notice of Revocation of Registry Identification Card(s)

Dear Mrs. Arais

The Maine Department of Administrative & Financial Services, Office of Cannabis Policy (Department) is responsible for the administration and oversight of the Maine Medical Use of Cannabis Program (MMCP). Protection for authorized conduct requires compliance with the Maine Medical Use of Marijuana Act and program rules. Pursuant to its authority under 22 M.R.S., Chapter 558-C, §2430-F, the Department revokes the following Registry Identification Card(s): CGR 30650. Such revocations are effective three (3) calendar days after the date of this notice.

I. Justification for revocation:

The Department's decision to revoke your Registry Identification Card(s) is based on your violation of the Maine Medical Use of Marijuana Act. More specifically, the Department's MMCP field investigation staff have provided the Department with sufficient evidence to demonstrate the following statutory and regulatory violations:

- On April 12, 2022, Field Investigator Daniel Summers sent you an email with an attached questionnaire to begin correspondence with you and to schedule an upcoming caregiver inspection on two or more occasions.
- 2. On April 15, 2022, after receiving no answer to his email, FI Summers called the contact phone number listed for you. Your husband, Tonny Arais answered and had a conversation with FI Summers. He confirmed that the email and phone number is also used by you. Mr. Arais informed FI Summers that you were not in the area and would have to get back to him on a date and time that would work for you.
- 3. Mr. Arais confirmed for FI Summers that your availability would be either April 21st or 22nd of 2022. He requested that FI Summers call then to confirm a date for inspection. Mr. Arais also confirmed for FI Summers that you had in fact received his email with an attached questionnaire listing the questions commonly asked during an inspection. FI Summers also asked Mr. Arais whether you would be present as you are also a caregiver

Phone: (207) 287-3282 Fax: (207) 287-2671 www.maine.gov/dafs/ocp/ and was due for an inspection. Mr. Arais informed FI Summers that you would be present as well.

- 4. On April 21, 2022, during Mr. Arais conversation with FI Summers, via phone, he asked Mr. Arais about a date for inspection that would be good for you. Mr. Arais informed FI Summers that both of you were in Miami, Florida taking care of an ill relative and that he did not know when you would be able to return to the State of Maine.
- 5. On April 26, 2022, FI Summers went to address to see if you were in fact living there. FI Summers placed business cards in the doorway as well as the door located in between the two bay garage doors and left the property. FI Summers then went to the town office and confirmed the owner of the property to be Rafael Duarte.
- 6. On April 27, 2022, FI Summers received a telephone call from a man who identified himself as Ralph "Rafael" Duarte, the owner of the address. FI Summers learned that you and your husband were evicted from the property in February, 2022. FI Summers learned that you and your husband have not been on the property or in the State of Maine since that time.
- 7. On April 27, 2022, FI Summers attempted to reach out to you by phone as well as text messaging. FI Summers did not hear back from either of you. Other attempts were made on April 28th, May 4th, May 5th, May 6th. FI Summers received no response from you.
- 8. In addition to the first inspection request sent to you on April 6, 2022 by the Office of Cannabis Policy, a second and final inspection request was sent to you and on May 11, 2022 with instructions to immediately contact FI Summers and schedule an inspection no later than May 17, 2022 at 5:00 PM. You were provided his contact information. As of June 7, 2022, you have not contacted him.

For these reasons, your eligibility to participate in the MMMP has been revoked.

- Willful failure to comply with an inspection, a violation of 22 MRS Section 2430-G (2)(C).
- You are no longer a resident of Maine since you were evicted from your home address in Brownville in February 2022. Since that time, you have not informed OCP of any new domicile in Maine and have been living in Miami, Florida. If you are not domiciled in Maine, you no longer qualify to be a registered caregiver and so are in violation of the statute. 22 MRS §§ 2423-A (2) and 2422(13-B).

II. Registration Revocation and Right to Request an Administrative Hearing:

Pursuant to 22 M.R.S. §2430-F, the Department may suspend or revoke a registry identification card for violation of Chapter 558-C and the rules adopted by the Department. A person who has had authorization for conduct under Chapter 558-C revoked due to failure to comply with Chapter 558-C and rules adopted by the Department may request an administrative hearing. If you would like to request an administrative hearing, please notify the Department in writing within thirty (30) calendar days of the revocation effective date at the address information provided above. A request for an administrative hearing should be sent to Vernon Malloch, Deputy Director of Operations by email at Vernon.Malloch@maine.gov or USPS at 162 State House Station, 19 Union Street, Augusta, Maine 04333-0062. If the Department does not receive a hearing request in accordance with the policy, the revocation becomes final.
