Subject: Notice of Revocation of Registry Identification Card

Dear Stephanie,

The Maine Department of Administrative & Financial Services, Office of Cannabis Policy (the Department) is responsible for the administration and oversight of the Maine Medical Use of Cannabis Program (MMCP). The Department hereby revokes the following Registry Identification Card: **STEPHANIE MICHELLE KREAMER**, **RIC18914**. This revocation is effective three (3) calendar days after the date of this notice.

## Justification for revocation:

The Department's decision to revoke your Registry Identification Card is based upon notification from the Office of the State Controller that the money order provided by you to pay for your registration fees was returned. You were notified of this on June 22, 2023 by the Department and requested to replace the returned money order in the amount of \$51.00, as well as the \$20.00 returned check fee. To date you have not paid the annual registration fee, annual fee for a criminal history check or the returned check fee, as required by the Maine Medical Use of Cannabis Act, Section 242-A(10).

For these reasons, your authorization to participate in the MMCP has been revoked. Please immediately return your Registry Identification Cards to:

## Registration Revocation and Right to Judicial Review:
