Subject: Notice of Revocation of Registry Identification Card(s)

Dear Ms. White:

The Maine Department of Administrative & Financial Services, Office of Marijuana Policy (Department) is responsible for the administration and oversight of the Maine Medical Use of Marijuana Program (MMMP). Protection for authorized conduct requires compliance with the Maine Medical Use of Marijuana Act and program rules. Pursuant to its authority under 22 M.R.S., Chapter 558-C, §2430-F, the Department revokes the following Registry Identification Card(s): CGR27744 and CGE831. Such revocations are effective three (3) calendar days after the date of this notice.

I. Justification for revocation:

The Department's decision to revoke your Registry Identification Card(s) is based on your violation of the Maine Medical Use of Marijuana Act. More specifically, the Department's MMMP field investigation staff have provided the Department with sufficient evidence to demonstrate the following statutory and regulatory violations:

- The Department has made the following attempts to schedule inspections:
 - First Inspection Request Notice Letter emailed on March 5, 2020 via email
 - Additional Attempts to contact: April 14, 2020 a call was placed to phone number provided although that number is out of service, emailed remote questionnaire; May 26, 2020 Field Investigator Maddox went to grow location listed although no one was present; June 8, 2020 text message was sent with no response.
 - Second/Final Inspection Request Notice Letter on May 18, 2020 via email and US Postal Service.
- 22 M.R.S., Chapter 558-C, §2430-G(2)(C) authorizes Department to suspend, revoke or refuse to renew the Registration Identification Card or Registration Certificate of a registered caregiver, a registered dispensary, a marijuana testing facility or a manufacturing facility that refuses or willfully avoids 2 or more inspections.


For this reason, your eligibility to participate in the MMMP has been revoked. Please immediately return your Registry Identification Card to:

II. Registration Revocation and Right to Request an Informal Hearing:

Pursuant to 22 M.R.S. §2430-F, the Department may suspend or revoke a registry identification card for violation of Chapter 558-C and the rules adopted by the Department. A person who has had authorization for conduct under Chapter 558-C revoked due to failure to comply with Chapter 558-C and rules adopted by the Department may request an informal hearing. If you would like to request an informal hearing, please notify the Department in writing within thirty (30) calendar days of the revocation effective date at the address information provided above. If the Department does not receive a hearing request in accordance with the policy, the revocation becomes final.
