Maine Adult Use Marijuana Establishment Maine Resident Ownership for Business Entities Worksheet

Section 5(b): Maine Adult Use Marijuana Establishment – Business Entities with Only Natural Persons Who Are Maine Resident Only. For the business entity listed in Section 5(b) of the original application, list all natural persons with any ownership interest in that business. Title 28-B §202(2)(B) requires owners that are business entities being used to prove majority resident ownership must be owned entirely by Maine residents.

If you provide false information on your application, and/or do not disclose all information the application asks, your license is subject to denial, and you may be subject to criminal prosecution.
