1	When we migrate customers from a third-party SIS to PowerSchool, it incurs one-time, event-based implementation and training fees. This is common with most SIS vendors. They can vary based on district needs, and we don't see where to list these costs in the format provided on Appendix E. To be compliant, where would we list these costs? Is the DOE expecting those costs to be negotiated with the LEA directly, and therefore only asking for software/support/hosting costs? If not, should we provide a table with a fee schedule?	These costs will need to be negotiated directly with the LEAs. These costs are not covered under this RFP or any resulting contracts.
2	For compliance, where do we insert our response for "B. Requirements" in the required Proposal Format / Proposal Contents? It is not stated in the Proposal outline instructions in Part IV, A or B.	See Appendix H Proposed Services Discuss the Scope of Services referenced above in Part II of this RFP and what the Bidder will offer. Give particular attention to describing the methods and resources you will use and how you will accomplish the tasks involved. Also, describe how you will ensure expectations and/or desired outcomes as a result of these services will be achieved. If subcontractors are involved, clearly identify the work each will perform. Do not just indicate that your solution meets the requirements.
