CONTRACT PERIOD: Immediately thru July 31, 2017 with the option of two (2) one (1) year renewals. The optional one (1) year extensions are not guaranteed and will be offered at the will of the State of Maine as each contractual year closes. *First extension through July 31, 2018.*

EXTENSION OF CONTRACT: The Director of Purchases may, with the consent of the contractor extend the Contract period beyond the indicated expiration date.

<u>CANCELLATION OF CONTRACT:</u> The Division of Purchases reserves the right to cancel a contract with a thirty day written notice OR cancel immediately if the contractor does not conform to terms and conditions and specifications of this contract.

PRICES: Prices shown are to be net including transportation charges fully pre-paid by the contractor FOB destination with NO minimum order. Prices are to remain firm for the duration of the contract.

QUANTITIES: It is not known how many of each trash bag will be needed each year. It is understood and agreed that the contract will cover the actual quantities ordered by statewide agencies, regardless of the size of the order, over the length of the contract.

WORKMANSHIP: The bags shall be uniformly made, free from pinholes, tears, cuts, creases, wrinkles or other imperfections which might impair their usefulness.

<u>DELIVERY:</u> Orders must be shipped to all statewide facilities within ten (10) business days from the receipt of the order. The Contractor will be responsible for the delivery of material in first class condition at the point of delivery, and in accordance with good commercial practice. Orders delivered in less than first class condition will be rejected or will have to be picked up by the contractor.

SUBSTITUTIONS: Only items listed on this master agreement can be ordered and shipped. No bags can be substituted without prior approval from the Division of Purchases. Orders with substituted items will be rejected or will have to be picked up by the contractor at their expense.

<u>ORDERING PROCEDURE:</u> Delivery orders (DO) will be created in AdvantageME for all orders over \$5000.00. Orders in the amount of \$5,000.00 or less can be ordered using a DO or by using a Procurement Card (Credit Card). If a DO is used the DO will be e-mailed to the email address set up in AdvantageME by the Vendor (<u>bids@centralpoly.com</u>) as a .pdf file. <u>State of Maine CONTRACTORS:</u> The State of Maine Department of Transportation utilizes an outside contractor to purchase and distribute parts and supplies.
