- **Welcome/Introductions:** Michael Conathan (Lead Project Consultant) welcomed the Task Force and introduced the consulting team.

- **Draft Report Impressions:** Mr. Conathan walked the Task Force through a draft report that was presented to the group preceding the meeting. Members offered

overall impressions of the report and specific feedback related to its findings and recommendations.

• **Next Steps**: Mr. Conathan provided an overview of work to be completed up to and including the submission of the final report on January 31, 2025. A proposed final report, which includes feedback from this Task Force meeting, will be shared with the group on or near January 24, 2025.

Discussion

Task Force members provided thoughtful guidance that included a general call to 1) tighten the report; 2) identify more specific Maine blue economy examples to help legislators see what is currently happening in their backyards; 3) reorder and prioritize the list of recommendations and to consider adding recommendations related to food and data collection; 4) to be very clear where the Maine State Legislature can be helpful in implementing the proposed recommendations; and 5) note that some Task Force members are not aligned on findings and recommendations made in past reports (e.g., the Maine Offshore Wind Roadmap).

Consultants will draft a final report based on feedback from the Task Force.
