<u>Item 1: Welcome</u>

- Strategic plan was developed over a year and a half ago; implementation was put on hold as we shifted to pandemic response
- ERC put together ideas on how to get us from our new baseline to the implementation
 of the strategic plan. Martha will lead the implementation help us prioritize the work
 to get it jumpstarted, set clear milestones, see what's working and not working as we
 progress

Strategic Plan Overview:

- Economic Development Strategic Plan vision: Want to give Maine people an unmatched quality of life and good paying jobs
- Is it a strategy or a plan?
 - Both It's a strategy that can be used by a lot of different groups, but it's also a project-managed plan
- Diversity, inclusion & equity lens

 Want to make sure we have diverse representation of people working on this, that there's an inclusive process, and that we're getting at products that have some level of equity across Maine

Item 2: Review ERC Recommendations against 10-Year Plan

ERC Recommendations Mapped Against 10-Year Plan:

- There is a lot of overlap between the ERC recommendations and the strategic plan. Our team will need to work on questions of sequencing
 - What do we need to prioritize now? This will be a key question for the work groups

How do we see the ERC recommendations and the 10-year plan fitting together?

Key Issues:

- Should Health Care and DEI have separate, dedicated workstreams, or should the steering committee work to harmonize these objectives across the 7 strategy areas?
- Is there already a health care workstream happening elsewhere that we should just pull in, or would we need to create a whole new team?
- How do we best support public-private partnerships?

<u>Item 3: Review and Update Portfolio Management Approach</u>

- The Executive Steering Committee should serve two roles:
 - 1. the block and tackle implementation work group
 - 2. the thought leadership/advisory role

Key Issues:

- Are additional resources are needed for the portfolio management work?
- How do we bring in the private perspective through direct representation on the steering committee, or by leveraging the current steering committee's networks?
- We can reach out to the ERC members to see if any of them have interest in joining the steering committee. Would be good to have representation from one of the two cochairs of each ERC topic group.

- Need to emphasize that the work groups will be responsible for "doing the work" and moving these projects forward not just an advisory role
- How does DOT fit into the broader strategic plan?
 - What does workforce transportation look like and how do we create equity there?
 - How do we make sure people can get to work? What infrastructure is needed?
 - o How do we think differently about what transportation should be?
- We should coalesce around our joint priorities so we can speak with a unified voice.

<u>Item 4: Review of Proposed Work Group Make Up – map networks/affiliations, make</u> any needed adjustments

- We want to recognize that the people involved in the steering committee and work groups represent many affiliations.
- As we look at the work groups, we also want to consider if there's already an existing network doing a big piece of the work.

Possible additions to the executive steering committee?

 - CEI is represented by Keith on the childcare part of the Modern Infrastructure work group
 - Wick Johnson was suggested for the Promoting Innovation work group

Key Issues:

- We are currently State gov't heavy. Should we bring in more private sector representation from the start?
- Do we want representation from **regional** (EDDs), **federal**, and **philanthropic** partners at this level? Or do we just reach out to these 3 groups periodically throughout the process?

Promote Innovation

 As the Maine Innovation Economy Advisory Board (MIEAB) gets revitalized, they could play an advisory role in this work group

Modern Infrastructure

- Should have more transit representation, e.g.:
 - Greg Jordan Greater Portland Metro
 - Sara Devlin Bangor Area Comprehensive Transportation System
- Composition of initial group will hinge upon which projects are prioritized

Regulatory and Business Climate

- Work group already met with Melanie
- Could add someone from the Secretary of State's office (corporate registration side – Cathy or Tammy)

Ubiquitous Connectivity

o Connect Maine Authority is an existing org who can manage this work

Hubs of Excellence

- Could start with the Roux institute and work out from there
- Possible communities to start with:
 - Bangor
 - Portland
 - Greenville
 - Rangeley
- Want to think about the hub and spoke model even if we start with metro areas, we need to think about how we engage with rural communities, too
- Potentially get EDDs involved in developing hubs of excellence within their regions
