<u>Davis-Bacon Acts</u>		
If a contract exceeds \$2,000, all laborers and mechanics employed by the Contractor and any Subcontractor on construction work pursuant to this Contract shall be paid wages at rates not less than the prevailing wages contained in the Wage Determination for County, Maine, as determined by the United States Department of Labor. Furthermore, each Contractor or Subcontractor shall submit to the Town of weekly payrolls for each week from the time the work is started on the project until it is completed. Weekly payrolls shall be submitted promptly, preferably, no later than seven working days following completion of the work week and shall be numbered sequentially, and the final payroll marked "Final."

The Contractor or any Subcontractor shall be prohibited from inducing, by any means, any person employed in the construction, completion or repair of any public building or public work to give up any part of the compensation to which he or she is otherwise entitled.
