Stakeholder Engagement -

Recommendation:

- 1. Incorporate public health and DEI into existing work group projects and workflows by adding project team members as needed
- 2. Use Request for Collaboration process to identify and "officially designate" Strategic Plan partners/collaborators around the key Opportunity Intersect areas of the Strategic Plan these are areas that call for public/private partnerships and cross industry sector interests
