<p><b>Reinstatement applications w/disclosures of unlicensed practice. All licensure categories of practice except for sedation permits.*</b></p> <p>Board delegated to staff the ability to relicense otherwise qualified individuals who have disclosed unlicensed practice. The delegation includes authorizing board staff, in coordination with the Office of the Attorney General, to initiate a complaint, and to offer the licensee a consent agreement to resolve the technical violation.
