Eco Maine d/b/a ecomaine Cumberland County South Portland/Scarborough, Maine A-697-71-F-R Departmental Findings of Fact and Order Air Emission License Renewal

FINDINGS OF FACT

After review of the air emission license renewal application, staff investigation reports, and other documents in the applicant's file in the Bureau of Air Quality, pursuant to 38 Maine Revised Statutes (M.R.S.) § 344 and § 590, the Maine Department of Environmental Protection (Department) finds the following facts:

I. REGISTRATION

A. Introduction

Eco Maine d/b/a ecomaine (ecomaine) has applied to renew their Air Emission License permitting the operation of equipment associated with their closed balefill landfill in South Portland and Scarborough, Maine.

This facility is accessed by 85 Scott Drive in Westbrook, Maine.

B. Emission Equipment

The following equipment is addressed in this air emission license:

Ecomaine may operate small stationary engines smaller than 0.5 MMBtu/hr. These engines are considered insignificant activities and are not required to be included in this license. However, they are still subject to applicable State and Federal regulations. More information regarding requirements for small stationary engines is available on the Department's website at the link below.

Additionally, ecomaine may operate <u>portable</u> engines used for maintenance or emergencyonly purposes. These engines are considered insignificant activities and are not required to be included in this license. However, they may still be subject to applicable State and Federal regulations.

C. Definitions

<u>Continuously</u> means equally spaced data points with at least one valid data point in each successive 15-minute period. A minimum of three valid 15-minute periods constitutes a valid hour. This definition is used with respect to operation of parameter monitors required by this license.

<u>Portable or Non-Road Engine</u> means an internal combustion engine which is portable or transportable, meaning designed to be and capable of being carried or moved from one location to another. Indicia of transportability include, but are not limited to, wheels, skids, carrying handles, dolly, trailer, or platform. This definition does NOT include engines which remain or will remain at a location (excluding storage locations) for more than 12 consecutive months or a shorter period of time for an engine located at a seasonal source. <u>A location is any single site</u> at a building, structure, facility, or installation. Any engine that replaces an engine at a location and that is intended to perform the same or similar function as the engine replaced will be included in calculating the consecutive time period.

An engine is <u>not</u> a non-road (portable) engine if it remains or will remain at a location for more than 12 consecutive months or for a shorter period of time if sited at a seasonal source. A seasonal source is a source that remains in a single location for two years or more and which operates for fewer than 12 months in a calendar year. If an engine operates at a seasonal source for one entire season, the engine does not meet the criteria of a non-road (portable) engine and is subject to applicable stationary engine requirements.

<u>Records</u> or <u>Logs</u> mean either hardcopy or electronic records.

D. Application Classification

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the date this license was issued.

The application for ecomaine does not include the licensing of increased emissions or the installation of new or modified equipment. Therefore, the license is considered to be a renewal of currently licensed emission units only and has been processed through *Major* and *Minor Source Air Emission License Regulations*, 06-096 Code of Maine Rules (C.M.R.) ch. 115.

E. Facility Classification

The facility is licensed as follows:

· As a natural minor source of criteria pollutants, because no license restrictions are necessary to keep facility emissions below major source thresholds for criteria pollutants; and

• As an area source of hazardous air pollutants (HAP), because the licensed emissions are below the major source thresholds for HAP.

II. BEST PRACTICAL TREATMENT (BPT)

A. Introduction

In order to receive a license, the applicant must control emissions from each unit to a level considered by the Department to represent Best Practical Treatment (BPT), as defined in *Definitions Regulation*, 06-096 C.M.R. ch. 100. Separate control requirement categories exist for new and existing equipment.

BPT for existing emissions equipment means that method which controls or reduces emissions to the lowest possible level considering:

- the existing state of technology;
- the effectiveness of available alternatives for reducing emissions from the source being considered; and
- the economic feasibility for the type of establishment involved.

B. Solid Waste Landfill

Ecomaine operates and maintains a closed balefill landfill. This landfill is separate from ecomaine's ash landfill where it disposes of ash from its nearby waste-to-energy (WTE) facility. Municipal solid waste is sometimes temporarily stored on site and later backhauled to the WTE facility.

1. New Source Performance Standards (NSPS)

Ecomaine is not subject to Standards of Performance for Municipal Solid Waste Landfills That Commenced Construction, Reconstruction, or Modification On or After May 30, 1991, but before July 18, 2014, 40 C.F.R. Part 60, Subpart WWW, or Standards of Performance for Municipal Solid Waste Landfills That Commenced Construction, Reconstruction, or Modification After July 17, 2014, 40 C.F.R. Part 60, Subpart XXX. Ecomaine is a closed landfill that has not initiated any activities that would be considered a construction, reconstruction, or modification since before 1991.

2. National Emissions Standards for Hazardous Air Pollutants (NESHAP)

Ecomaine is not subject to *National Emission Standards for Hazardous Air Pollutants: Municipal Solid Waste Landfills*, 40 C.F.R. 63, Subpart AAAA.

This regulation applies to municipal solid waste landfills which are a major source of HAP, are collocated with a major source of HAP, have a design capacity greater than 2.5 million megagrams (Mg) with uncontrolled nonmethane organic compounds (NMOC) emissions greater than 50 Mg/year, or includes a bioreactor. Ecomaine is not a major source of HAP or collocated with a major HAP source; it does not have a design capacity greater than 2.5 million megagrams; and it does not operate a bioreactor.

3. Control Equipment

Ecomaine operates a collection and control system consisting of a (LFG) collection system and flare (Flare #1). The flare has a maximum heat value of 26.6 MMBtu/hr and is designed to achieve 98% overall destruction of total hydrocarbons including NMOC. Flare #1 also uses a small amount of propane to fuel a pilot light.

The release of uncontrolled LFG is prevented through the use of a thermocouple which continuously monitors the presence of flame at the flare. If Flare #1 experiences a flame loss during operation, the controller causes the automatic shutdown of the flare and closes a pneumatic "fail safe" valve at the main gas header. The unit initiates an automatic relight sequence after an operator-specified cool down period, and the flare is brought back online.

4. BPT Findings

 SO_2 is emitted as a result of combustion of total reduced sulfur compounds (TRS) in the LFG. Sampling of the LFG performed in 2009 indicated that the concentration of TRS in the landfill are less than 10 parts per million by volume (ppmv). Subsequent field sampling continues to confirm these results. Therefore, emissions of SO_2 from Flare #1 were conservatively calculated based on a TRS concentration of 46.9 ppmv based on AP-42, Section 2.4.4.2, page 2.4-8, dated 8/24.

Compliance shall be demonstrated by limiting the amount of LFG sent to the flare to no more than 870 scfm at 50% methane. The flow rate of the LFG shall be continuously monitored by a thermal mass flow meter with a standard cubic feet per minute (scfm) digital totalizer. The gas flow rate is considered a parameter monitor. The flare gas oxidation unit is also equipped with an hour meter that displays the cumulative number of hours of operation of the flare system. The hour meter is considered a parameter monitor.

Visible emissions from Flare #1 shall not exceed 10% opacity on a six-minute block average basis.

Ecomaine shall monitor and record the LFG extraction system and final cap system performance on a quarterly basis in accordance with the monitoring program in Attachments A and B of Appendix J of the Balefill Closure Application dated September 18, 1995.

Ecomaine shall keep records of any maintenance activities performed (planned or unplanned) on Flare #1.

5. Facility-Wide Emission Limits

The facility-wide emission limits for criteria pollutants are based on the following assumptions:

- Operation of Flare #1 at its maximum licensed capacity (i.e., 870 scfm at 50% methane);
- A TRS concentration of 46.9 ppmv; and
- Facility-wide emission limits for VOC and HAP including fugitive emissions.

The annual limit for total hazardous air pollutants is included to demonstrate that the facility is an area source of HAP.

The Department finds the annual limits listed above to represent BPT for emissions from the landfill.

Compliance with the facility-wide annual emission limits shall be demonstrated by calculating actual emissions at least once annually. Calculations of annual emissions shall be completed no later than February 15th of the following calendar year.

Emissions of PM, PM_{10} , $PM_{2.5}$, SO_2 , NO_x , and CO shall be calculated based on the amount of LFG sent to Flare #1 and the licensed emission factor for the flare.

Compliance with the VOC and HAP annual limits shall be based on a combination of emissions from Flare #1 and fugitive emissions. Emissions of VOC and HAP from Flare #1 shall be calculated based on the amount of LFG sent to the flare and concentration data based on EPA's Compilation of Emission Factors (AP-42), Section 2.4, *Municipal Solid Waste Landfills*. Fugitive VOC emissions from the landfill shall also be calculated in accordance with AP-42, Section 2.4.

C. Fugitive Emissions

Ecomaine shall not cause emissions of any fugitive dust during any period of construction, reconstruction, or operation without taking reasonable precautions. Such reasonable precautions shall be included in the facility's continuing program of best management practices for suppression of fugitive particulate matter. See 06-096 C.M.R. ch. 101, § 4(C) for a list of potential reasonable precautions.

Ecomaine shall not cause or allow visible emissions within 20 feet of ground level, measured as any level of opacity and not including water vapor, beyond the legal boundary of the property on which such emissions occur. Compliance with this standard shall be determined pursuant to 40 C.F.R. Part 60, Appendix A, Method 22.

D. Annual Emissions

The table below provides an estimate of facility-wide annual emissions for the purposes of calculating the facility's annual air license fee and establishing the facility's potential to emit (PTE). Only licensed equipment is included, i.e., emissions from insignificant activities are excluded. Similarly, unquantifiable fugitive particulate matter emissions are not included except when required by state or federal regulations. Maximum potential emissions were calculated based on the following assumptions:

- Operating Flare #1 at 870 scfm at 50% methane for 8,760 hours/year;
- Combustion of LFG with a TRS concentration of 46.9 ppmv; and
- Facility-wide emission limits for VOC and HAP.

This information does not represent a comprehensive list of license restrictions or permissions. That information is provided in the Order section of this license.

III. AMBIENT AIR QUALITY ANALYSIS

The level of ambient air quality impact modeling required for a minor source is determined by the Department on a case-by-case basis. In accordance with 06-096 C.M.R. ch. 115, an ambient air quality impact analysis is not required for a minor source if the total licensed annual emissions of any pollutant released do not exceed the following levels and there are no extenuating circumstances:

The total licensed annual emissions for the facility are below the emission levels contained in the table above and there are no extenuating circumstances; therefore, an ambient air quality impact analysis is not required as part of this license.

This determination is based on information provided by the applicant regarding licensed emission units. If the Department determines that any parameter (e.g., stack size, configuration, flow rate, emission rates, nearby structures, etc.) deviates from what was included in the application, the Department may require ecomaine to submit additional information and may require an ambient air quality impact analysis at that time.

ORDER

Based on the above Findings and subject to conditions listed below, the Department concludes that the emissions from this source:

- will receive Best Practical Treatment,
- will not violate applicable emission standards, and
- will not violate applicable ambient air quality standards in conjunction with emissions from other sources.

The Department hereby grants Air Emission License A-697-71-F-R subject to the following conditions.

<u>Severability</u>. The invalidity or unenforceability of any provision of this License or part thereof shall not affect the remainder of the provision or any other provisions. This License shall be construed and enforced in all respects as if such invalid or unenforceable provision or part thereof had been omitted.

STANDARD CONDITIONS

(1) Employees and authorized representatives of the Department shall be allowed access to the licensee's premises during business hours, or any time during which any emissions units are in operation, and at such other times as the Department deems necessary for the purpose of performing tests, collecting samples, conducting inspections, or examining and copying records relating to emissions (38 M.R.S. § 347-C).

- (2) The licensee shall acquire a new or amended air emission license prior to beginning actual construction of a modification, unless specifically provided for in Chapter 115. [06-096 C.M.R. ch. 115]
- (3) Approval to construct shall become invalid if the source has not commenced construction within eighteen (18) months after receipt of such approval or if construction is discontinued for a period of eighteen (18) months or more. The Department may extend this time period upon a satisfactory showing that an extension is justified, but may condition such extension upon a review of either the control technology analysis or the ambient air quality standards analysis, or both. [06-096 C.M.R. ch. 115]
- (4) The licensee shall establish and maintain a continuing program of best management practices for suppression of fugitive particulate matter during any period of construction, reconstruction, or operation which may result in fugitive dust, and shall submit a description of the program to the Department upon request. [06-096 C.M.R. ch. 115]
- (5) The licensee shall pay the annual air emission license fee to the Department, calculated pursuant to Title 38 M.R.S. § 353-A. [06-096 C.M.R. ch. 115] Payment of the annual air emission license fee for ecomaine is due by the end of May of each year. [38 M.R.S. § 353-A(3)]
- (6) The license does not convey any property rights of any sort, or any exclusive privilege. [06-096 C.M.R. ch. 115]
- (7) The licensee shall maintain and operate all emission units and air pollution systems required by the air emission license in a manner consistent with good air pollution control practice for minimizing emissions. [06-096 C.M.R. ch. 115]
- (8) The licensee shall maintain sufficient records to accurately document compliance with emission standards and license conditions and shall maintain such records for a minimum of six (6) years. The records shall be submitted to the Department upon written request. [06-096 C.M.R. ch. 115]
- (9) The licensee shall comply with all terms and conditions of the air emission license. The filing of an appeal by the licensee, the notification of planned changes or anticipated

noncompliance by the licensee, or the filing of an application by the licensee for a renewal of a license or amendment shall not stay any condition of the license. [06-096 C.M.R. ch. 115]

(10) The licensee may not use as a defense in an enforcement action that the disruption, cessation, or reduction of licensed operations would have been necessary in order to maintain compliance with the conditions of the air emission license. [06-096 C.M.R. ch. 115]

- (11) In accordance with the Department's air emission compliance test protocol and 40 C.F.R. Part 60 or other method approved or required by the Department, the licensee shall:
 - A. Perform stack testing to demonstrate compliance with the applicable emission standards under circumstances representative of the facility's normal process and operating conditions:
 - 1. Within sixty (60) calendar days of receipt of a notification to test from the Department or EPA, if visible emissions, equipment operating parameters, staff inspection, air monitoring or other cause indicate to the Department that equipment may be operating out of compliance with emission standards or license conditions; or
 - 2. Pursuant to any other requirement of this license to perform stack testing.
 - B. Install or make provisions to install test ports that meet the criteria of 40 C.F.R. Part 60, Appendix A, and test platforms, if necessary, and other accommodations necessary to allow emission testing; and
 - C. Submit a written report to the Department within thirty (30) days from date of test completion.[06-096 C.M.R. ch. 115]
- (12) If the results of a stack test performed under circumstances representative of the facility's normal process and operating conditions indicate emissions in excess of the applicable standards, then:
 - A. Within thirty (30) days following receipt of the written test report by the Department, or another alternative timeframe approved by the Department, the licensee shall re-test the non-complying emission source under circumstances representative of the facility's normal process and operating conditions and in accordance with the Department's air emission compliance test protocol and 40 C.F.R. Part 60 or other method approved or required by the Department; and
 - B. The days of violation shall be presumed to include the date of stack test and each and every day of operation thereafter until compliance is demonstrated under normal and

representative process and operating conditions, except to the extent that the facility can prove to the satisfaction of the Department that there were intervening days during which no violation occurred or that the violation was not continuing in nature; and

- C. The licensee may, upon the approval of the Department following the successful demonstration of compliance at alternative load conditions, operate under such alternative load conditions on an interim basis prior to a demonstration of compliance under normal and representative process and operating conditions.

- (13) Notwithstanding any other provisions in the State Implementation Plan approved by the EPA or Section 114(a) of the CAA, any credible evidence may be used for the purpose of establishing whether a person has violated or is in violation of any statute, regulation, or license requirement. [06-096 C.M.R. ch. 115]
- (14) The licensee shall maintain records of malfunctions, failures, downtime, and any other similar change in operation of air pollution control systems or the emissions unit itself that would affect emissions and that is not consistent with the terms and conditions of the air emission license. The licensee shall notify the Department within two (2) days or the next state working day, whichever is later, of such occasions where such changes result in an increase of emissions. The licensee shall report all excess emissions in the units of the applicable emission limitation. [06-096 C.M.R. ch. 115]
- (15) Upon written request from the Department, the licensee shall establish and maintain such records, make such reports, install, use and maintain such monitoring equipment, sample such emissions (in accordance with such methods, at such locations, at such intervals, and in such a manner as the Department shall prescribe), and provide other information as the Department may reasonably require to determine the licensee's compliance status. [06-096 C.M.R. ch. 115]
- (16) The licensee shall notify the Department within 48 hours and submit a report to the Department on a quarterly basis if a malfunction or breakdown in any component causes a violation of any emission standard (38 M.R.S. § 605). [06-096 C.M.R. ch. 115]

SPECIFIC CONDITIONS

(17) Solid Waste Landfill

A. The amount of LFG sent to Flare #1 shall not exceed 870 scfm at 50% methane. Compliance shall be demonstrated through continuous monitoring of the LFG flow rate. Ecomaine shall maintain records of this monitoring data. [06-096 C.M.R. ch. 115, BPT] B. Emissions from Flare #1 shall not exceed the following:

- D. Visible emissions from Flare #1 shall not exceed 10% opacity on a six-minute block average basis. [06-096 C.M.R. ch. 115, BPT]
- E. Monitoring and Recordkeeping
 - 1. Ecomaine shall continuously monitor for the presence of a flame at Flare #1 with a thermocouple. Ecomaine shall maintain records of all periods of operation during which the pilot flame is absent.
 - 2. Ecomaine shall continuously monitor gas flow rate to Flare #1 with a thermal mass flow meter and record gas flow with a scfm digital totalizer. The gas flow rate is considered a parameter monitor.
 - 3. Ecomaine shall use an hour meter to display the cumulative number of hours of operation of Flare #1 and shall maintain a log recording hours of operation. The hour meter is considered a parameter monitor.
 - 4. Ecomaine shall monitor and record the LFG extraction system and final cap system performance on a quarterly basis in accordance with the monitoring program in Attachments A and B of Appendix J of the Balefill Closure Application dated September 18, 1995.
 - 5. Ecomaine shall maintain records documenting all routine and non-routine maintenance on Flare #1.

- F. Facility-Wide Emission Limits

- 2. Compliance with the facility-wide annual emission limits shall be demonstrated by calculating actual emissions at least once annually. Calculations of annual emissions shall be completed no later than February 15th of the following calendar year.
- 3. Emissions shall be calculated in accordance with the following or other methods as approved by the Department.
 - a. Emissions of PM, PM_{10} , $PM_{2.5}$, NO_x , SO_2 , and CO shall be calculated based on the amount of LFG sent to Flare #1 and the licensed emission factor for the flare.
 - b. Emissions of VOC and HAP from Flare #1 shall be calculated based on the amount of LFG sent to the flare and concentration data based on EPA's Compilation of Emission Factors (AP-42), Section 2.4, *Municipal Solid Waste Landfills*. Fugitive VOC emissions from the landfill shall also be calculated in accordance with AP-42, Section 2.4

(18) **Parameter Monitors**

A. All parameter monitors shall be operated, calibrated, and maintained in accordance with the manufacturer's specifications.

B. If any parameter monitor is recording accurate and reliable data less than 98% of the source-operating time within any quarter of the calendar year, the Department may initiate enforcement action. The Department may include in that enforcement action any period of time that the parameter monitor was not recording accurate and reliable data during that quarter unless the licensee can demonstrate to the Department's satisfaction that the failure of the system to record such data was due to the performance of established quality assurance and quality control procedures or unavoidable malfunctions.

(19) **Fugitive Emissions**

- A. Ecomaine shall not cause emissions of any fugitive dust during any period of construction, reconstruction, or operation without taking reasonable precautions. Such reasonable precautions shall be included in the facility's continuing program of best management practices for suppression of fugitive particulate matter. See 06-096 C.M.R. ch. 101, § 4(C) for a list of potential reasonable precautions.
- B. Ecomaine shall not cause or allow visible emissions within 20 feet of ground level, measured as any level of opacity and not including water vapor, beyond the legal boundary of the property on which such emissions occur. Compliance with this standard shall be determined pursuant to 40 C.F.R. Part 60, Appendix A, Method 22.

If the Department determines that any parameter value pertaining to construction and (20)operation of the emissions units, including but not limited to stack size, configuration, flow rate, emission rates, nearby structures, etc., deviates from what was submitted in the application or ambient air quality impact analysis for this air emission license, ecomaine may be required to submit additional information. Upon written request from the Department, ecomaine shall provide information necessary to demonstrate AAOS will not be exceeded, potentially including submission of an ambient air quality impact analysis or an application to amend this air emission license to resolve any deficiencies and ensure compliance with AAQS. Submission of this information is due within 60 days of the Department's written request unless otherwise stated in the Department's letter. [06-096 C.M.R. ch. 115, § 2(O)]
