FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

I. Registration

Final Gift USA, LLC (Final Gift) has requested the transfer of Air Emission License A-887-71-J-R (issued October 20, 2014) as amended in A-887-71-K-A (issued June 20, 2017) from Veterinary Support Services to Final Gift USA, LLC through a letter to the Department dated December 3, 2018. The facility offers pet cremation services and will continue to do business as Veterinary Support Services.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

II. Transfer Requirements

A. Title, Right, or Interest

In their application, Final Gift submitted copies of property deeds transferring ownership of the facility to Final Gift. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

B. Technical Capacity and Intent

Final Gift's acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence that Final Gift has the technical capacity and intent to comply with their air emission license.
