

Dear Frank,

Thank you for submitting the above referenced report for review. Gray & Pape did an excellent job in conducting the archeological survey, including determining testing locations and in reporting results. I want to thank you and Gray & Pape for your willingness to add the metal detecting survey, which succeeded in identifying at least two historic loci that may be associated with Arnold Expedition camps.

We agree with the recommendation that the Noble's Ferry West site is potentially significant and that it should be subjected to a Phase II archaeological investigation for the purpose of determining National Register eligibility. As is noted in the Section 6.3 proposal, the focus of the Phase II should be assessment of overall site condition including presence of intact features, determination of period of occupation and site boundaries. Testing to date has already provided important information. A one percent sample of the site is recommended in the proposal for the Phase II investigation. If the site is determined to be NR eligible, it is important to leave the site as intact as possible for future research. Given the importance of minimizing impacts and site preservation, excavation of 25 m2 may be more than is necessary to make a NR determination. This amount of testing will also result in the potential removal of a substantial number of artifacts that will then have to be stabilized (iron) and curated. Given these issues, I would encourage Gray & Pape to remain focused on the overall objective and to excavate only what is necessary to perform the assessment.

I have read the Phase I Archaeological Investigation report for the Shawmut project by Richard Will and Karen Mack, TRC Ellsworth, dated January 28, 2020 (received here February 3rd).

The report is acceptable in all respects. We accept the recommendation that Phase II archaeological testing is necessary for sites 53.97, 70.42, 70.43, and 70.44 to determine National Register eligibility and site boundaries.

Phase I archeological survey for this project is not complete. We accept the recommendation that test areas (TA) 3, 4, 5, 6, 8 and 14 be included in the future historic properties management plan with a periodic request for access to the landowers for access to complete the archaeological survey.
